Re: 2025 Genesee County Smart Growth Plan Review - Town of Batavia

Dear Felipe,

Following our recent correspondence and meetings, the Town of Batavia would like to submit a modified proposal for the 2025 Smart Growth Plan Review. This updated proposal includes:

- Minor boundary adjustments to better align the Smart Growth Area with parcel lines.
- **A major reduction** along both sides of Alexander Road, limiting the Smart Growth boundary to a 370-foot offset from front property lines. This change helps balance the net gain and loss associated with the proposed Reserve Area additions.
- The original proposal to redesignate two Reserved Smart Growth Areas as Priority Smart Growth Areas.

#### **Summary of Proposed Changes:**

Previous Smart Growth Area	12,275 acres
2013 Additions to Reserve Area	+1,026 acres
2013 Deletions	-697 acres
Current Area (including Reserved)	12,604 acres
Proposed Additions	+57 acres
Proposed Deletions	-531 acres
Proposed Smart Growth Area (including Reserved)	12,130 acres
Proposed Net Change in 2025	-474 acres
Proposed Net Change from Original Smart Growth	-145 acres

As shown above, the Town previously accepted deletions in 2013 to accommodate the addition of Reserved Smart Growth Areas. Therefore, any redesignation of these areas should not be considered a net addition to the Smart Growth Area.

Additionally, the Town is not prepared to implement certain boundary modifications proposed by the County Planning Department without further planning. To ensure alignment with both the County Smart Growth Plan and the Town's Comprehensive Plan, we recommend deferring these changes to the next review cycle. This will allow for a more collaborative and thoughtful planning process.









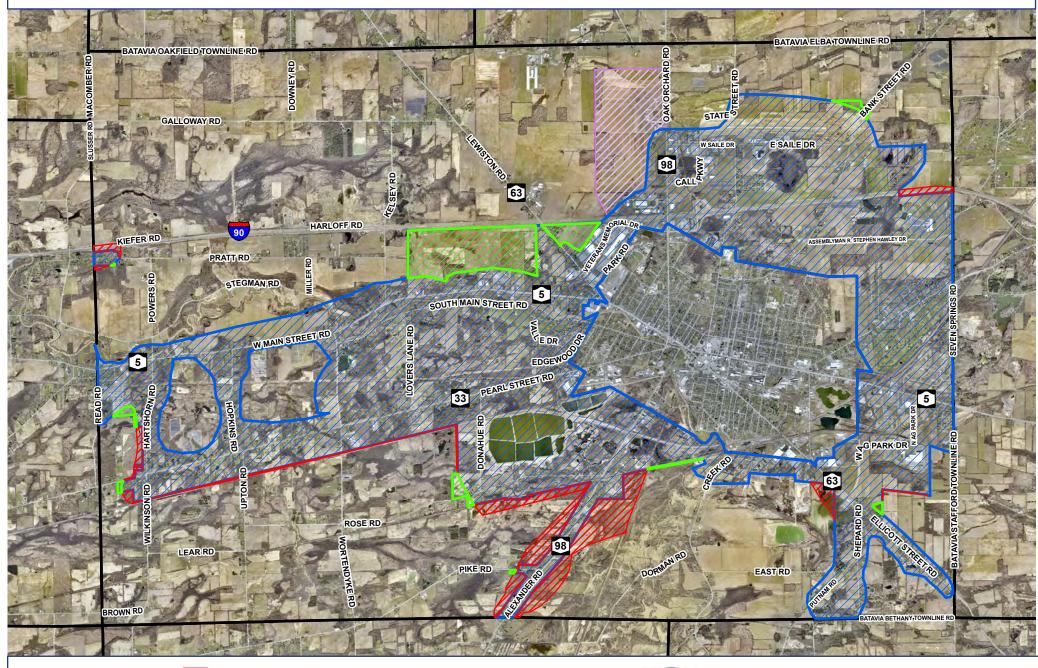

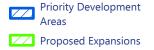


### **Map 6 - Town of Batavia Revised Proposal by the Town**


