TO ADOPT LOCAL LAW D OF THE YEAR 2024-IN RELATION TO THE SALARIES OF COUNTY OFFICERS OF THE COUNTY OF GENESEE, ELECTED OR APPOINTED FOR A FIXED TERM - ADOPTION OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the following proposed Local Law D of the Year 2024 was duly introduced to the Genesee County Legislature in accordance with the Law: LOCAL LAW INTRODUCTORY D OF THE YEAR 2024 FOR COUNTY OF GENESEE, NEW YORK IN RELATION TO THE SALARIES OF COUNTY OFFICERS OF THE COUNTY OF GENESEE, ELECTED OR APPOINTED FOR A FIXED TERM BE IT ENACTED by the Genesee County Legislature as follows:

Section 1. The salary of County Officers set forth below shall be as follows:

- Section 2. The above salary shall take effect January 1, 2025.
- Section 3. This Local Law is subject to referendum on petition pursuant to the provisions of Section 24 of the Municipal Home Rule Law.
- Section 4. This Local Law shall take effect upon proper filing with the Office of the Secretary of State, and

WHEREAS, the Clerk of the Genesee County Legislature posted a certified notice of the Public Hearing on said proposed Local Law on the bulletin board in the Old Courthouse and on the County website, and

WHEREAS, the Clerk of the Genesee County Legislature published in the Batavia Daily News, the official newspaper of the County of Genesee, the notice of Public Hearing on a Proposed Local Law Introductory D of the Year 2024, and

WHEREAS, a public hearing was held at 5:30 p.m. on the 25th day of November 2024 in Batavia, New York, at which time all interested persons who wished to speak was heard. Now, therefore, be it

RESOLVED, that "A LOCAL LAW IN RELATION TO THE SALARIES OF COUNTY OFFICERS OF THE COUNTY OF GENESEE, ELECTED OR APPOINTED FOR A FIXED TERM" to be known as Local Law Number 1, Year 2025, for the County of Genesee as introduced on November 6th and adopted on November 25th, 2024.

Legislator Deleo seconded the resolution, which was adopted by 174 (Yunker-26 absent) votes.
