#### FIFTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, March 13, 2019

The Genesee Legislature met in Regular Session on Wednesday March 13, 2019 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Stein assisted with the audit. Prayer was offered by Legislator Torrey followed by the Pledge to the Flag.

In addition to our regular meeting, Chairman Bausch opened a Public Hearing to obtain the views of citizens, public agencies, and other interested parties on the housing and community development needs of the County and the County's submission of a request to the New York State Office of Community Renewal for approval of the use of Community Development Block Grant Program Income to provide assistance in the form of a grant to Yancey's Fancy, Inc. to fund the purchase of equipment. All interested parties were invited to be heard.

Legislator Maha presented Notre Dame High School representatives Mr. Wade Bianco, Mrs. Sharon Korzelius, Faith Falkowski and Collin Piser with a proclamation designating March as Inclusion Month at Notre Dame High School. Legislator Maha shared his appreciation of efforts made by Notre Dame Faculty and students to raise awareness and understanding of people with differing abilities and creating a culture of acceptance and inclusion. His appreciation goes even further as the parent of a disabled daughter. Ms. Falkowski accepted the proclamation and thanked the Legislature for their support and recognition.

Minutes of the February 27, 2019 Legislature meeting were approved upon motion of Legislator Clattenburg seconded by Legislator Deleo with the following correction from Legislator Maha, third paragraph add "on drafting a written plan" carried.

Legislator Stein announced the Soil & Water Conservation District Farm of the Year for 2018 is Barniak Farms. The award will be presented at the Annual Celebrate Agriculture Dinner on March 16, 2019. Inter County Association has their March meeting scheduled for March 15<sup>th</sup> at the Del Lago in Seneca County. As the Genesee County representative she reported on recent work of the Municipal Electric and Gas Alliance (MEGA) with regard to the Community Choice Aggregate Program. Legislator Young attended the Chamber of Commerce Annual Awards Dinner and the Genesee County Economic Development Annual Luncheon meeting and commented on the level of business and work going on in the county. Chairman Bausch commented on his attendance at the Genesee Regional Transportation Authority meeting where there was much discussion on the proposed round-about in Alabama. It was stated that additional funds are needed for this project. He also attended the Genesee Regional Planning Council meeting and noted that State and Federal project funding is scattered. He commented that the GAIN loan funds, a revolving loan fund, is tapped out and additional funding is not anticipated. Legislator Clattenburg commented that she and County Manager Jay Gsell spoke to Genesee County Youth LEAD program participants about getting involved in government and their community.

An out-of-state travel request for Eve Hens, Purchasing Department, to travel to Austin, Texas from August 24-29 for the National Institute of Government Procurement Forum at a cost to the County of \$2,490 was presented. Legislator Maha commented that he would vote no on the request due to lack of information on the workshops and sessions especially in light of the cost to the County, Legislator Torrey stated he had similar concerns and Legislator Clattenburg asked for the department head to be present at the committee meeting when the request was on the agenda to answer questions. The out of state travel request was tabled upon motion of Legislator Stein seconded by Legislator Dibble, carried.

County Manager Jay Gsell stated the County may have its first Raise the Age client. The State has not yet approved our submitted Plan however, we will track costs associated with this client if they do become our first RTS case. Mr. Gsell stated CJAC will discuss best practices for services at the County Jail. These discussions will be occurring around the same time the architects will be working on design options. He also referenced the cost associated with the Governor's proposal for electronic poll books which comes close to \$130,000 for Genesee County.

**WHEREAS,** Four (4) members' terms have expired, with one (1) member in good standing eligible for reappointment; and

WHEREAS, The Committees on Human Services and Ways & Means do recommend reappointment at this time. Now Therefore, Be it

**RESOLVED,** That the Genesee County Legislature does hereby reappoint the following to the Genesee County Office for the Aging Advisory Council to serve a three year term effective January 1, 2019 through December 31, 2021.

Foster, Consultant Dietitian, 33 Willmont Street, Rochester, N.Y. 14609-3617 for the provision of Registered Dietitian Services for the Older Americans Act, NYS Office for the Aging, and other contractual Nutrition Programs operated by Genesee County Office for the Aging; and

**WHEREAS**, This is the 2<sup>nd</sup> renewal of a five year contract with potential for 2 additional 1 year renewals for provision of Registered Dietitian Services including kitchen monitoring, meal site monitoring, home delivered meal program monitoring, nutrition education, nutrition counseling, menu planning/analysis and administrative duties, as required and the Committee on Human Services does recommend approval at this time. Now, therefore, Be it

**RESOLVED,** That the Chairman of the Genesee County Legislature is hereby authorized and directed to execute the necessary document to award the contract with Ellen E. Foster, Consultant Dietitian for the provision of Title III C-1, Title III C-2, WIN and other nutrition

funded services provided through the Genesee County Office for the Aging for 8 hours of dietitian services per week at a rate of \$36 per hour, not to exceed \$14,976 annually, April 1, 2019 – March 31, 2020.

**<u>Budget Impact</u>**: Neutral. \$36 per hour for 8 hours of dietitian service per week, not to exceed \$14,976 annually, is already budgeted in the county 2019 Office for the Aging budget.

**WHEREAS**, current New York State law permits municipal debt officers to sell bonds electronically in a closed auction format only; and

**WHEREAS**, in a closed auction format a bidder does not receive information with respect to the status or rank of its bid prior to the conclusion of the bid submission period and has no opportunity to improve its bid based on its rank compared to other bidders; and

**WHEREAS**, in an open auction format a bidder learns the rank of its bid at the instant the bid is submitted and is permitted to improve its bid, multiple times, until the conclusion of the bid submission period; and

**WHEREAS**, previous attempts to authorize the additional option of an electronic open auction format for municipal debt officers statewide to sell municipal bonds have unanimously passed in

the NYS Senate and never made it out of Local Government Committee in the NYS Assembly (A.2536/S.3849), and

**WHEREAS**, the residents of Genesee County would benefit from the enactment of such legislation in that it provides a means to reduce the borrowing costs associated with funding capital projects; and Now Therefore, BE IT

**RESOLVED,** that the Genesee County Legislature supports the enactment of state legislation that would grant municipal debt officers practicing within Genesee County the additional option to sell municipal bonds via an electronic open auction; and be it further

**RESOLVED**, that the Clerk of the Genesee County Legislature is hereby directed to cause a copy of this resolution to be forwarded to the Honorable Assemblyman Stephen Hawley and Senator Michael Ranzenhofer and anyone else deemed necessary.

Legislator Torrey seconded the resolution which was adopted by 298 votes, Legislator Hilchey (28) absent.

# RESOLUTION NO. 95 AUTHORIZING THE USE OF COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM INCOME FUNDS TO ASSIST YANCEY'S FANCY, INC.

Legislator Dibble offered the following resolution:

**WHEREAS**, Genesee County (the "County") is the recipient of a Small Cities Community Development Block Grant in the amount of \$200,000 pursuant to a grant received from the New York State Housing Trust Fund Corporation represented by the New York State Office for Small Cities (OFSC) through the Community Development Block Grant (CDBG) Program (OFSC Grant # 444ME19-04) and a New York State Community Development Block Grant in the amount of \$100,000 pursuant to New York State NYSCDBG Program Community Development Block Grant Agreement Project NO. 444ME18-07 (collectively the "CDBG Grants"), and

WHEREAS, the proceeds of the CDBG Grants were provided to the Genesee County Chamber of Commerce (the "Chamber of Commerce") pursuant to certain Subrecipient Agreements (the "Subrecipient Agreements"), which provided for the use of the CDBG Grant proceeds to establish and operate a microenterprise revolving loan fund, and

**WHEREAS**, the cash on hand and loans receivable in the loan fund constitute Program Income, as defined in the CDBG regulations, which is subject to certain rules and regulations promulgated by the United States Department of Housing and Urban Development and the New York State Office of Community Renewal (OCR) regarding its use, and

**WHEREAS**, OCR has notified the County and other recipients of CDBG funds that it is requiring that all Program Income not spent on, or committed to, CDBG-eligible activities by March 31, 2019 be paid to the OCR by April 30, 2019, and

**WHEREAS**, any proposed use of Program Income prior to March 31, 2019 must be approved by OCR, and

WHEREAS, in order to address OCR's directive, the Chamber of Commerce has undertaken to sell its loan portfolio and the County and the Chamber of Commerce have agreed to terminate the Subrecipient Agreements and the Chamber of Commerce will remit to the County the Program Income in its possession, including cash on hand and the proceeds from the sale of its loan portfolio, which will be used or committed by the County to fund eligible CDBG activities, and

**WHEREAS**, the County wishes to utilize the Program Income to make a grant to Yancey's Fancy, Inc. to be used to fund the purchase of a piece of equipment which will allow the company to expand its artisanal cheese production, and

**WHEREAS**, the County has held a public hearing regarding the proposed use of Program Income to provide assistance to Yancey's Fancy, Inc. and **NOW THEREFORE BE IT** 

**RESOLVED,** that, subject to the approval of OCR, the County utilize its Program Income, as remitted to the County by the Chamber, in an amount not to exceed \$ 70,421.62 to provide a grant (the "Grant") to Yancey's Fancy, Inc. (the "Company") to be used to fund the purchase of equipment, and be it further

**RESOLVED**, that the County enter into a Grant Agreement with the Company which shall provide for the disbursement and use of the Grant proceeds to fund the purchase of equipment in a manner consistent with CDBG program requirements and which Grant Agreement shall include and be subject to the requirements of the CDBG program, including requirements for the creation and reporting of employment, such Grant Agreement to be subject to the approval of the County Attorney, and be it further

**RESOLVED**, that following the County Attorney's review, the Chair of the Legislature be, and hereby is, authorized to execute the Grant Agreement with the Company and such other documentation as is required to effectuate the actions approved in this Resolution, and be it further

**RESOLVED**, that the Chair of the Legislature is hereby designated as the Certifying Officer responsible for all activities associated with the federal environmental review process to be completed in conjunction with the project.

# A RESOLUTION OPPOSING ASSEMBLY BILL NO. 1261/SENATE BILL NO. 1947

Legislator Young offered the following resolution:

**WHEREAS**, the Genesee County Legislature supports the continued growth of business expansion, retention and attraction; and investments into workforce development, housing and healthy living projects, and

**WHEREAS,** Genesee County has used financial incentives to secure significant private sector investments amid competitive site selection searches; to allow Genesee County businesses to pursue projects expanding their workforce, production, and facilities; and to overcome competitive disadvantages from New York State's expensive business climate, and

**WHEREAS**, such public-private partnerships are necessary to enable revitalization of our downtowns, expand markets for agricultural products, create rewarding career pathways for our existing workforce and youth, and fulfill the delivery of transformational projects at the WNY STAMP campus in the town of Alabama, and

**WHEREAS,** projects assisted by the Genesee County Economic Development Center have returned a significant benefit to Genesee County, enabling pledges of \$33 million in capital investment, 99 new jobs, and construction of over 189,000 square feet of facilities in 2018; and over the past 17 years have enabled \$1.3 billion in capital investment, over 4,500 new jobs, and new construction and renovations totaling over 3.5 million square feet of facilities, and

**WHEREAS,** legislation is currently under consideration by the State Senate of New York and the State Assembly of New York which redefines public works projects to include private sector projects; and would impose prevailing wage requirements on all private sector investments receiving any incentives, grants, loans or assistance from Genesee County or the State of New York; including those to expand manufacturing, affordable and market rate housing, downtown revitalization, historic preservation and projects undertaken by non-profit organizations, and

**WHEREAS**, studies have projected a prevailing wage mandate would increase project costs by an additional 25 to 30 percent, resulting in fewer projects, fewer new jobs, and fewer investments into community needs in Genesee County; and past use of prevailing wage requirements in Ulster County and the City of Yonkers arrested economic development in those communities, therefore be it

**RESOLVED**, that the Genesee County Legislature reaffirms its support for the continued growth of Genesee County's economy and quality of life, and goes on record opposing Senate Bill 1947 and Assembly Bill 1261.

**RESOLVED**, that the clerk of the Legislature shall forward certified copies of this Resolution to the Governor of the State of New York Andrew Cuomo, Senate Majority Leader Andrea Stewart-Cousins, Senator Mike Ranzenhofer, Speaker of the New York State Assembly Carl Heastie, Assemblyman Steve Hawley, the Inter County Association and NYSAC.

Legislator Torrey seconded the resolution which was adopted by 298 votes, Legislator Hilchey (28) absent.
