## GENESEE COUNTY LEGISLATURE OLD COURT HOUSE – 7 MAIN STREET, BATAVIA, NY WEDNESDAY, APRIL 9, 2025

The Genesee County Legislature met in Regular Session on Wednesday, April 9, 2025 at 5:30 PM in the Legislative Chambers of the Old Courthouse.

Legislator Hawley offered to assist with the audit and Legislator Dibble offered the prayer and the Pledge to the Flag.

Roll Call was taken to establish a quorum with 8 in attendance: Legislators Stein, Hawley, Dibble, Torrey, Maha, Yunker, Clattenburg and Deleo with 1 absence (Klotzbach).

## 2025 SALARY SCHEDULE AMENDMENT/2025 MANAGEMENT SALARY SCHEDULE-DEPARTMENT OF SOCIAL SERVICES/CREATE FULL TIME ADOLESCENT BEHAVIORAL SPECIALIST I/REMOVE FULL TIME CHILD CARE WORKER- APPROVAL OF

Legislator Clattenburg offered the following resolution:

**WHEREAS,** the Student Transformation and Empowerment Program (S.T.E.P.) continues to work with at-risk youth in Genesee County, and

**WHEREAS**, there is an urgent need to have these services in place to monitor these youth and provide motivation and mentorship to minimize the risk of failing school, being placed out-of-home, engaging in risky or disruptive behavior, the Commissioner of Social Services is requesting an amendment to the 2025 Management Salary Schedule to add one (1) additional full-time Adolescent Behavioral Specialist (ABS) I position, and

**WHEREAS**, the number of youth placed out of their home into Cluster Homes has decreased due to preventive services such as S.T.E.P., making the need to fill a vacant Child Care Worker position less critical, the Commissioner of Social Services is requesting to delete one (1) full-time Child Care Worker position, and

**WHEREAS**, the Committees on Human Services and Ways and Means did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Genesee County Treasurer and Human Resources Director are hereby authorized and directed to amend the 2025 Management Salary Schedule by creating the full-time, Management Grade 106, Adolescent Behavioral Specialist I position and amend the 2025 Employee Salary Schedule by deleting a vacant full-time, CSEA Grade 8 Child Care Worker position, effective immediately upon legislative approval.

Budget Impact: The 2025 total cost for a full-time ABS I is \$83,266 and the 2025 total cost for a full-time Child Care Worker is \$79,447. This would increase the personnel line by \$3,819. With periodic vacancies throughout the department, this additional cost will already be covered in 2025. State and Federal reimbursement ranges between 66-100% as determined by case specific eligibility.

**WHEREAS**, there is an urgent need to have an additional part-time position filled to assist with current caseloads, the Commissioner of Social Services is requesting an amendment to the 2025 Employee Salary Schedule to create one (1) additional, part-time Social Welfare Examiner position to cover these duties, and

**WHEREAS**, the Social Services department also requests to delete the vacant full-time Social Welfare Examiner position that was held vacant for the prior creation of a part-time Social Welfare Examiner position, and

**WHEREAS**, the Committee on Human Services and Ways and Means did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED**, that the Genesee County Treasurer and Human Resources Director are hereby authorized and directed to amend the 2025 Employee Salary Schedule by creating one (1) part-time Social Welfare Examiner position, CSEA Grade 12S, and deleting one (1) vacant full-time Social Welfare Examiner position, effective immediately upon legislative approval.

Budget Impact: The full-time CSEA Grade 12S Social Welfare Examiner position (200-014) is currently vacant and not included in the 2025 budget, per a previous Resolution to create the part-time Social Welfare position in 2022. There is currently one (1) part-time Social Welfare Examiner position budgeted for 37.5 hours/week with zero fringe included. We will delete the full-time position and create an additional part-time position, resulting in no change to the 2025 budget since total hours for two part-time positions (37.5) are already budgeted. State and Federal reimbursement ranges between 66-100% as determined by case specific eligibility.
