WHEREAS, Genesee County issued RFP 2023-107 for inmate communication services at the Genesee County Jail, and three proposals were received, and

WHEREAS, after careful review by the Genesee County Sheriff, Purchasing Director and Jail Superintendent, it was determined that our current provider Securus Technologies, LLC provided the best combination of competitive pricing and services, and

WHEREAS, the Committee on Ways & Means did review this request and does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary documents to award the bid for jail inmate communication services to Securus Technologies, LLC, 4000 International Parkway, Carrollton, Texas 75007, to include 84% commission paid on inmate telephone calls to Genesee County, for the period of May 1, 2023, through April 30, 2025, with the option to renew for three (3) additional one-year periods upon mutual, written consent of both parties under the same terms and conditions as the original Agreement.

Budget Impact: Inmate communication costs have been budgeted for in the 2023 budget.

CAPITAL PROJECT/BUDGET AMENDMENT-DISPATCH CENTER CONSOLE FURNITURE-APPROVAL OF

WHEREAS, Resolution 64 duly adopted on February 9, 2022, did create a capital project for the Dispatch Center console Furniture in the amount of \$320,000, and

WHEREAS, the Sheriff and Director of Emergency Communications have experienced unexpected expenses related to the project, and

WHEREAS, in consultation with the County Manager, County Treasurer, and Director of Information Technology, the Director of Emergency Communications has requested additional funding in the amount of \$23,094, and

WHEREAS, the Ways and Means Committee did review this request and does recommend approval at this time. Now, therefore be it

RESOLVED, the Genesee county Treasurer is hereby authorized and directed to amend the 2023 Budget and the Dispatch Center Console Furniture capital project by increasing A.9950.9 – Transfer to Capital in the amount of \$23,094, offset by an increase in A1000.1110.0 – 1% Sales Tax in a like amount. Increase in H.3397.2080.0000 – Public Safety – Capital Project Expense by \$23,094, offset by an increase in H.3397.5031 – Public Safety – Capital Project – Interfund Transfer in a like amount.

Budget Impact: Funding for the additional expense of \$23,094 will be covered by 1% sales tax proceeds

Legislator Yunker seconded the resolution, which was adopted by 200 votes

WHEREAS, the Genesee County Health Department has requested use of funds from the Opioid Settlement A688.1 budget to the Health Department A4010 budget to offset the wastewater lab service expenses, and

WHEREAS, the Committee of Human Services and Ways and Means has reviewed this request and do concur for adoption at this time. Now, therefore, be it

RESOLVED, that the Genesee County Legislature hereby accepts the bids of \$1,000 per site per month received from Biobot Analytics Inc. from May 1, 2023 to April 30, 2026, and be it further **RESOLVED**, that the Genesee County Treasurer is hereby authorized and directed to make the following 2023 Budget Amendment: Increase A.4010.2735 – Public Health - Opioid Settlement Funds by \$18,000 offset by an increase in A.4010.4800.0600 – Public Health – Program Expense -Opioid Settlement in a like amount. WHEREAS, the Committee on Ways and Means did review this request and does recommend approval at this time. Now, therefore, be it

Budget Impact: There is no budget implications for Genesee County.

WHEREAS, an Accounting Supervisor in the Office for the Aging did request a classification review of their position, and

WHEREAS, a reclassification review was conducted by the Genesee County Human Resources Department, resulting in a recommendation by the Human Resources Director that an Accounting Supervisor position be reclassified to Administrative Officer, and

WHEREAS, the Committees on Human Services and Ways and Means did review this

recommendation and recommends approval at this time. Now, therefore, be it

RESOLVED, that the Genesee County Treasurer and Human Resources Director are hereby authorized and directed to amend the 2023 Genesee County Managements' Salary Schedule by creating one position of Administrative Officer, Grade 115; and amend the 2023 Genesee County Employees' Salary Schedule by deleting the position of Accounting Supervisor, CSEA Grade 18, effective April 17, 2023.

Budget Impact: Neutral. The increase in salary, FICA and retirement totals \$10,906 and is covered by existing personnel and fringe lines and is not expected to impact the adopted 2023 county budget or change county share.

Legislator Yunker seconded the resolution, which was adopted by 200 votes.

RESOLUTION NO. 128 PERMISSION TO APPLY AND ACCEPT GRANT FUNDS-OFFICE FOR THE AGING/ ROCHESTER AREA COMMUNITY FOUNDATION MURIEL H. MARSHALL FUNDS- APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the Director of the Office for the Aging did request permission to apply for two grant awards: \$88,000 for Centralized Intake, and \$16,225 for Marketing Coordination from the Rochester Area Community Foundation's Muriel H. Marshall Fund for the Aging each for the period of July 1, 2023- June 30, 2024 and these grants total \$104,225 in Marshall Fund grant revenue; and

WHEREAS, the Committees on Human Services and Ways and Means did review this request and do recommend acceptance of these grants. Now, therefore, be it

RESOLVED, that the Chairperson of the Genesee County Legislature is authorized and directed to sign the Rochester Area Community Foundation grant award letters acknowledging acceptance of these Muriel H. Marshall Fund for the Aging grants by Genesee County; and is authorized to enter into any and all agreements under the grants awarded to contract for goods and services to meet the requirements under each of the grants awarded.

Budget Impact: \$104,225 of Marshall H. Marshall Fund grant awards were calculated into the approved 2023 county budget for Centralized Intake and Marketing Coordination.
