Information Technology Director Mike Burns presented a two-year maintenance renewal agreement with InStream to provide a 24-month service agreement to maintain the Canon ImagePROGRAF iPF825 plotter\printer located in the Genesee County Planning department. Agreement with InStream dba Biel's, is effective May 28, 2023 through May 28, 2025 at a cost of \$1,675. This was approved for placement on the next Legislature Agenda upon motion of Legislator Stein seconded by Legislator Torrey, carried unanimously.

Assistant County Manager and Genesee County STOP-DWI Coordinator Tammi Ferringer has identified individual to serve on the STOP-DWI Advisory Board as a citizen member. Santina Marceill of Elba, New York to serve a term effective immediately through December 31, 2025. This was approved for placement on the next Legislature Agenda upon motion of Legislator Maha seconded by Legislator Stein, carried unanimously.

Job Development Bureau Director Teresa Van Son reported that Jay Lazarony Sr. Employment and Training Director of the Job Development Bureau has requested that amendments be made in her budget to allow for the creation of a part-time, Disability Resource Program for the GLOW Region at the request of the New York State Department of Labor, NY Systems Change and Inclusive Opportunities Network (NYSCION). Amended 2023 Job Development Bureau Budget in the amount of \$25,000 and the Genesee County Employees Salary schedule by creating one part-time Disability Resource Coordinator (DRC) position CSEA Grade 16S, effective upon approval of the Legislature.

This was approved for placement on the next Legislature Agenda upon motion of Legislator Maha seconded by Legislator Stein, carried unanimously.

Job Development Bureau Director Teresa Van Son reported the Genesee County Job Development Bureau has been approved by the GLOW Workforce Development Board as the Contractor to provide WIOA Adult, Dislocated Worker, and Youth Services for Genesee County. The grant is a one-year agreement from July 1, 2023, and continues until June 30, 2024 with a budget of \$298,100.00. This was approved for placement on the next Legislature Agenda upon motion of Legislator Torrey seconded by Legislator Maha, carried unanimously.

Job Development Bureau Director Teresa Van Son presented a department review which was comprised of WIOA Grant, JDB Funding, Staff changes, Services, miscellaneous, what is on the horizon such as Virtual Career Center, Northstar Digital Literacy and Oculus Virtual Reality.

County Manager Matt Landers requested to the committee to table Rave Mobile Safety resolution. This was a contract with Rave Mobile Safety, to provide mass notification services and support for the term 5/1/2023 through 4/31/2026, for a one-time set up fee of \$500 and an annual fee of \$4,000. Both Michael Burns and Matt Landers has decided there may be a better option for the County. Would like the resolution to be tabled. A motion to table this resolution made by Legislator Stein, seconded by Legislator Maha.

County Manager Matt Landers reported County-wide policies and procedures have been adopted and periodically updated. Additionally new policies and procedures are also necessary to ensure compliance with new and changing regulations, rules and laws. An electronic policy & procedure manual has been developed to include categorized policies & procedures along with associated forms and plans or handbooks.
