WHEREAS, it is anticipated that there will be an increase of approximately \$3,900 in the annual contributions of the County of Genesee for the fiscal year ending March 31, 2023. In future years, this cost will vary as the billing rates and salary of Steven R. Grice change. Now therefore, be it

RESOLVED, that the Genesee County Legislature hereby requests the New York State Legislature to support and pass Senate Bill No. S.7240A and Assembly Bill No. A.8025A which is the legislation necessary to grant Tier III retroactive status to Steven Grice to his initial 1981 employment date. Be it further

RESOLVED, the Genesee County Legislature hereby authorizes execution and submission of the Home Rule form as required by the Home Rule Request. Be it further

RESOLVED, that a copy of this resolution for Home Rule Request be sent to Senate Home Rule Counsel, Assembly Home Rule Counsel, Governor Kathy Hochul, Senator Edward Rath III, and Assemblyman Stephen Hawley.

Budget Impact Statement: A charge of approximate \$18,600 will be charged to the retirement benefits line of the County Clerk.

Legislator Hawley seconded the resolution which was adopted with two-thirds vote of 420 votes.
