RESOLUTION NO. 253 IN SU SENA

IN SUPPORT OF ASSEMBLY BILL A.9990 AND SENATE BILL S.8999-AN ACT TO AMEND THE EDUCATION LAW IN RELATION TO PERMITTING SCHOOLS LOCATED WITHIN THE STATE TO PURCHASE CERTAIN NEW YORK MILK – APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, whole milk is a healthy, nutritious, and arguably essential option for the developing bodies of children. At 97% fat free, whole milk is a complete protein and contains thirteen vital nutrients and vitamins, including many that need to be consumed with fat to be absorbed by the body; and

WHEREAS, while many consider skim, low-fat, and reduced-fat milks to be healthier options, researchers are now discovering surprising benefits for those who drink whole milk. Recent studies have found that those who consume whole-fat dairy may have a lower risk for heart disease

and type 2 diabetes, lower blood pressure, an increased satiety without weight gain, and better sleep. Even more unexpected, it has been found that children who drink full-fat dairy are leaner and less likely to be overweight compared to their peers who do not consume whole milk. As evidence continues to show that whole milk is a beneficial beverage, many dieticians are recommending that people, children especially, consume the type of milk they prefer as part of an overall healthy diet; and

WHEREAS, despite its health benefits, whole milk is currently prohibited from being served in schools due to a federal restriction put in place ten years ago to lower childhood obesity and diabetes rates. While the policy was well-intentioned at the time, over the last decade, we have witnessed these rates continue to rise and have learned that the restriction could even be exacerbating the problem; and

WHEREAS, dairy is an important part of a healthy diet for children, and it is essential that kids are drinking their milk: Since whole milk was prohibited from being served to students, the amount of milk consumed in schools has decreased and the amount of milk wasted has increased; and

WHEREAS, restricting milk choice negatively impacts the health, growth, and development of kids in our State. Simply put, children do not get the benefits of milk's vitamins and nutrients if they are not drinking it; and

WHEREAS, New York's dairy farmers, who take great pride in producing such a nutritious product, are feeling the strain of having a limited milk market in schools; and

WHEREAS, Assembly Bill A.9990 and companion Senate Bill S.8999 not only guarantees that children across the State, who receive meals at school, can once again have the fresh, New York produced, whole milk they enjoy, but it also supports New York's struggling dairy farmers. Now, therefore, be it

RESOLVED, the Genesee County Legislature fully supports Assembly Bill A.9990 and Senate Bill S.8999. Be it further

RESOLVED, that copies of this resolution be sent to Governor Hochul, Assemblyman Stephen Hawley, Senator Edward Rath, Senator George Borrello, Commissioner Ball, New York State Agricultural and Markets, Inter-County Association of Western New York, Chair of the Education Committee (Assembly and Senate), New York State Farm Bureau and Genesee County Farm Bureau.

WHEREAS, the Director of the Office for the Aging did present a renewal of contract established through RFP 2018-103 with Willcare, Inc., c/o parent company, LHC Group, Inc. 901 Hugh Wallis Rd South Lafayette, LA 70508 to serve as Fiscal Intermediary for Consumer Directed In-home Services operated by Genesee County Office for the Aging, and

WHEREAS, homecare services are in great demand with the rising number of frail and/or chronically ill elders in our county needing in-home and community support services with homecare agencies unable to fill homecare cases due to lack of in-home workers; and

WHEREAS, under Consumer Directed In-home Services, control is shifted to the consumer (or eligible consumer representative) for budgeting, care planning, decision making, arranging for services and staffing; and

WHEREAS this is the final renewal contract with same terms and conditions as the original agreement for provision of Fiscal Intermediary services with regard to Consumer Directed Inhome Services and the Committee on Human Services does recommend approval at this time, and **WHEREAS**, the Committee of Human Services did review this request and does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chairman of the Genesee County Legislature is hereby authorized and directed to execute the necessary document to award the contract to Willcare, Inc. to serve as Fiscal Intermediary for Genesee County Office for the Aging Consumer Directed In-home Services under Expanded In-home Services for the Elderly, Title III E, and other in-home services funds at a cost of \$20.51/hour for <u>CDIS-Basic Worker</u> and \$23.11/hour for <u>CDIS-Enhanced Worker</u>, not to exceed \$19,968 for the period of June 1, 2022-May 31, 2023.

Budget Impact: All in-home services are already incorporated into our 2022 County budget. No additional County funds will be required. Rate is \$20.51 for CDIS-Basic Worker and \$23.11/hour for CDIS-Enhanced Worker. A total of \$19,968 is designated for CDIS for the period of 6/1/2022-5/31/2023.

WHEREAS, Monroe County Medical Examiner's Office will be referring all laboratory testing and toxicology services to NMS Labs with costs billed separately to the Health Department, and **WHEREAS,** the Genesee County Public Health Director presented a service agreement with NMS Labs, and

WHEREAS, the Committees on Human Services did review the request and do recommend approval at this time. Now therefore, be it
