INTERMUNICIPAL AGREEMENT-TREASURER /OAKFIELD-ALABAMA CENTRAL SCHOOL DISTRICT TAX COLLECTION – APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the Oakfield-Alabama Central School District contacted the Genesee County Treasurer to request that the Treasurer's Office continue to handle the collection of school property taxes for the 2023-24 school tax year, and

WHEREAS, the Genesee County Treasurer has reviewed this request with the Oakfield-Alabama Central School District and has proposed to collect the taxes for a fee of \$3.75 per tax bill, and

WHEREAS, the Oakfield-Alabama Central School District has prepared an agreement which has been reviewed and approved by the County Attorney, and

WHEREAS, the Committee on Ways and Means has reviewed the agreement and does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to sign the agreement with the Oakfield-Alabama Central School District for the collection of the 2023-24 school property taxes.

Budget Impact: Annual revenue of approximately \$10,000 received from this agreement will offset the cost of providing the requested tax collection services.

WHEREAS, the Genesee County Self-Funded Health Plan is required under the Consolidated Omnibus Budget Reconciliation Act (COBRA) to offer plan participants continuation of health coverage to all qualified individuals, and

WHEREAS, recent changes to the Health Plan triggered a mid-contract review of current COBRA administrative service contracts, and

WHEREAS, the Genesee County Human Resources Director did present a contract for the provision of medical and dental COBRA Administration Services, and

WHEREAS, the Committee on Ways and Means did review this recommendation and does concur. Now, therefore be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to enter into contract with P & A Group, 17 Court Street, Buffalo, NY 14202, for provision of medical and dental COBRA Administration services; and to execute any and all other documentation related to this contract. Effective August 1, 2023 through December 31, 2024.

Budget Impact: \$395,500 is included in the 2023 budget for the administration of the Self-Funded Health Plan. A projected annual cost of \$4,632 for COBRA Administration services and an annualized savings of approximately \$7,445.

WHEREAS, the RFP has been sent back out to bid with a return date of May 31, 2023, and a start date estimated to be September 1, 2023, and

WHEREAS, the Committee on Ways and Means did review this request, and do recommend approval at this time. Now, therefore be it

RESOLVED, that the Genesee County Treasurer and Human Resources Director are hereby authorized and directed to amend the 2023 Employee Salary Schedule by extending the positions of CSEA Grade 18N Community Health Nurse and CSEA Grade 16N Registered Professional Nurse positions through August 31, 2023, at an estimated cost of \$24,537.

WHEREAS, Genesee County Emergency Services Dispatch Center NG-911 Upgrade Capitol Project was established by Resolution #____ in June of 2023, and

WHEREAS, a proposal was solicited from Frontier Communications of America, Inc. as the authorized sales and service provider for the manufacturer of the Genesee County Emergency Services Dispatch Center 9-1-1 system, and

WHEREAS, this project is an upgrade and not a replacement of Genesee County Emergency Services Dispatch Center 9-1-1 system, New York State Division of Homeland Security and Emergency Services has authorized Frontier Communications of America, Inc. as a sole source provider, and

WHEREAS, after careful review by the Sheriff, County Attorney, County Purchasing Director, Information Technology Director, and the Director of Emergency Communications, it is recommended a contract for the Next Generation 9-1-1 equipment, engineering, and support services to upgrade our current 9-1-1 system be awarded to Frontier Communications Corporation at a cost not to exceed \$856,837.81, which includes \$50,000.00 contingency for unforeseen complications, and

WHEREAS, the Ways & Means committee did review this proposal and does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature and the Genesee County Sheriff are hereby authorized and directed to enter into an agreement with Frontier Communications of America, Inc. 401 Merritt 7, Norwalk, CT 06851, for Next Generation 9-1-1 equipment, engineering, and support services to upgrade our current 9-1-1 system at a cost not to exceed \$856,837.81.

Budget Impact: The cost of this project (\$856,837.81) is from Capital Project Genesee County Emergency Services Dispatch Center NG-911 Upgrade.

Legislator Yunker seconded the resolution, which was adopted by 200 votes.

SET PUBLIC HEARING – A LOCAL LAW INTRODUCTORY C OF THE YEAR 2023 WITH REGARD TO THE IMPOSITION OF A MORTGAGE RECORDING TAX – APPROVAL OF

A RESOLUTION AUTHORIZING PHASE 3 OF THE WATER SUPPLY PROJECT IN AND FOR THE COUNTY OF GENESEE, NEW YORK, AT A TOTAL MAXIMUM ESTIMATED COST OF \$150,000,000 AND AUTHORIZING THE ISSUANCE OF NOT EXCEEDING \$150,000,000 BONDS OF SAID COUNTY TO PAY COSTS THEREOF

Legislator Clattenburg offered the following resolution:

RESOLUTION NO. 247

WHEREAS, all conditions precedent to the financing of the capital project hereinafter described, including compliance with the provisions of the State Environmental Quality Review Act, have been performed; and

WHEREAS, the Committee on Ways and Means does recommend approval at this time. Now, therefore, be it

RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the County Legislature of the County of Genesee, New York, as follows:

<u>Section 1.</u> Phase 3 of the water supply project is hereby authorized in and for the County of Genesee, New York, including pump stations, water storage tanks upgrades, transmission and distribution mains and incidental improvements and costs in connection therewith.

<u>Section 2.</u> The plan for the financing of the aforesaid purpose shall be by the issuance of \$150,000,000 bonds of said County, hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law; provided, however, that the amount of bonds shall be reduced to the extent of grants and other funding sources.

<u>Section 3.</u> It is hereby determined that the period of probable usefulness of the aforesaid class of objects or purposes is forty years, pursuant to subdivision 1 of paragraph a of Section 11.00 of the Local Finance Law.

<u>Section 4.</u> The faith and credit of said County of Genesee, New York, are hereby irrevocable pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. To the extent not paid from other sources, there shall annually be levied on all the taxable real property of said County, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

<u>Section 5.</u> Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the bonds herein authorized, including renewals of such notes, is hereby delegated to the County Treasurer, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said County Treasurer, consistent with the provisions of the Local Finance Law.

<u>Section 6.</u> All other matters except as provided herein relating to the serial bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability to issue serial bonds with substantially level or declining annual debt service, shall be determined by the County Treasurer, the chief fiscal officer of such County. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the County Treasurer shall determine consistent with the provisions of the Local Finance Law.

<u>Section 7.</u> The validity of such bonds and bond anticipation notes may be contested only if: 1) Such obligations are authorized for an object or purpose for which said County is not authorized to expend money, or

2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

3) Such obligations are authorized in violation of the provisions of the Constitution.

<u>Section 8.</u> This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

A LOCAL LAW INTRODUCTORY C OF THE YEAR 2023, A LOCAL LAW AMENDING LOCAL LAW NO. 1 OF THE YEAR 2020, WITH REGARD TO THE IMPOSITION OF A MORTGAGE RECORDING TAX WITHIN THE COUNTY OF GENESEE – ADOPTION OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the following resolution was duly introduced to Genesee County Legislature in accordance with the Law: LOCAL LAW INTRODUCTORY NO. C, YEAR 2023, and AMENDING LOCAL LAW 1 OF THE YEAR 2020 WITH REGARD TO THE IMPOSITION OF A MORTGAGE RECORDING TAX WITHIN THE COUNTY OF GENESEE Be it enacted, by the Legislature of the County of Genesee, State of New York as follows: Section 1. Section 1 of Local Law 1 of the Year 2020 is hereby amended to read as follows: Section 1. Imposition of Tax

- (a) Pursuant to Chapter 579 of the Laws of 2004, Local Law No. 1 of the year 2020 is hereby amended to end on <u>October 31, 2023</u> in accordance with Tax Law § 253-K, Recording Tax imposed by the County of Genesee.
- (b) Pursuant to Chapter 579 of the Laws of 2004 for the period beginning November 1, 2023 and ending November 1, 2025, there is hereby imposed, in the County of Genesee, a tax of \$0.25 for each \$100.00, and each remaining major fraction thereof of principal debt of obligation which is or under any contingency may be secured at the date of execution thereof, or at any time thereafter, by a mortgage or real property situated within the County of Genesee and recorded on or after November 1, 2023 and a tax of \$0.25 on such Mortgage if the principal debt or obligation which is or by an contingency may be secured by such mortgage is less than \$100.00.

Section 2. Effective Date

This local law shall take effect on <u>August 1, 2023</u> provided a certified copy thereof is mailed by registered or certified mail to the New York State Commissioner of Taxation and Finance at least 30 days prior to such date. Certified copies of this local law shall also be filed with the Genesee County Clerk, the Secretary of State and the State Comptroller within five days after the date it is

duly enacted. And,

WHEREAS, The Clerk of the Genesee County Legislature will post a certified notice of Public Hearing on said proposed Local Law on the bulletin board in the Old Courthouse, and
