**WHEREAS,** this module will allow for employees to electronically view and update certain payroll information, and

**WHEREAS,** the Genesee County Treasurer, Human Resources Director, and Information Technology Director recommend approval of the contract to purchase this module, and

**WHEREAS**, the Committee on Ways and Means has reviewed this recommendation and does concur. Now, therefore, be it

**RESOLVED**, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute the documentation necessary for the purchased of the eSuite module with Tyler Technologies, Inc, 5101 Tennyson Parkway, Plano, TX 75024 for one time fees in the amount of \$26,065 and recurring annual fees of \$5,712.

Budget Impact: Premium expense in the amount of \$170,313 will be included in the 2025 Self-Insurance budget and shall be apportioned to participants.

#### ESTABLISHING ENERGY BENCHMARKING REQUIREMENTS FOR CERTAIN COUNTY BUILDINGS -PLANNING DEPARTMENT/CLEAN ENERGY COMMUNITIES-APPROVAL OF

Legislator Maha offered the following resolution:

**WHEREAS,** buildings are the single largest user of energy in the State of New York. The poorest performing buildings typically use several times the energy of the highest performing buildings—for the exact same building use; and

WHEREAS, collecting, reporting, and sharing building energy data on a regular basis allows municipal officials and the public to understand the energy performance of municipal buildings relative to similar buildings nationwide, and equipped with this information the County of Genesee is able to make smarter, more cost-effective operational and capital investment decisions, reward efficiency, and drive widespread, continuous improvement; and

**WHEREAS**, the Genesee County Legislature desires to use Building Energy Benchmarking - a process of measuring a building's energy use, tracking that use over time, and comparing performance to similar buildings - to promote the public health, safety, and welfare by making available good, actionable information on municipal building energy use to help identify opportunities to cut costs and reduce pollution in the Genesee County; and

**WHEREAS**, the Genesee County Legislature desires to establish procedure or guideline for Genesee County staff to conduct such Building Energy Benchmarking; and

**WHEREAS**, the Committees on Public Services and Ways & Means did review the request and do recommend approval at this time. Now, therefore, be it

**NOW THEREFORE, IT IS HEREBY RESOLVED AND DETERMINED,** that the following specific policies and procedures are hereby adopted;

#### **BUILDING ENERGY BENCHMARKING POLICY/PROCEDURES**

#### **§1. DEFINITIONS**

(1) "Benchmarking Information" shall mean information generated by Portfolio Manager, as herein defined including descriptive information about the physical building and its operational characteristics.

(2) "Building Energy Benchmarking" shall mean the process of measuring a building's Energy use, tracking that use over time, and comparing performance to similar buildings.

(3) "Director" shall mean the head of the Department.

(4) "Covered Municipal Building" shall mean a building or facility that is owned or occupied by the County of Genesee that is 6,000 square feet or larger in size.

(5) "Department" shall mean the Department of Planning.

(6) "Energy" shall mean electricity, natural gas, steam, hot or chilled water, fuel oil, or other product for use in a building, or renewable on-site electricity generation, for purposes of providing heating, cooling, lighting, water heating, or for powering or fueling other end-uses in the building and related facilities, as reflected in Utility bills or other documentation of actual Energy use.

(7) "Energy Performance Score" shall mean the numeric rating generated by Portfolio Manager that compares the Energy usage of the building to that of similar buildings.

(8) "Energy Use Intensity (EUI)" shall mean the kBTUs (1,000 British Thermal Units) used per square foot of gross floor area.

(9) "Gross Floor Area" shall mean the total number of enclosed square feet measured between the exterior surfaces of the fixed walls within any structure used or intended for supporting or sheltering any use or occupancy.

(10) "Portfolio Manager" shall mean ENERGY STAR Portfolio Manager, the internet-based tool developed and maintained by the United States Environmental Protection Agency to track and assess the relative Energy performance of buildings nationwide, or successor.

(11) "Utility" shall mean an entity that distributes and sells Energy to Covered Municipal Buildings.

(12) "Weather Normalized Site EUI" shall mean the amount of Energy that would have been used by a property under 30-year average temperatures, accounting for the difference between average temperatures and yearly fluctuations.

#### §2. APPLICABILITY

(1) This policy is applicable to all Covered Municipal Buildings as defined in Section 2 of this policy.

(2) The Director may exempt a particular Covered Municipal Building from the benchmarking requirement if the Director determines that it has characteristics that make benchmarking impractical.

#### **§3. BENCHMARKING REQUIRED FOR COVERED MUNICIPAL BUILDINGS**

(1) No later than May 1, 2025, and no later than May 1 every year thereafter, the Director or his or her designee from the Department shall enter into Portfolio Manager the total Energy consumed by each Covered Municipal Building, along with all other descriptive information required by Portfolio Manager for the previous calendar year.

(2) For new Covered Municipal Buildings that have not accumulated 12 months of Energy use data by the first applicable date following occupancy for inputting Energy use into Portfolio Manager, the Director or his or her designee from the Department shall begin inputting data in the following year.

#### **§4. DISCLOSURE AND PUBLICATION OF BENCHMARKING INFORMATION**

(1) The Department shall make available to the public on the internet Benchmarking Information for the previous calendar year:

(a) no later than September 1, 2025 and by September 1 of each year thereafter for Covered Municipal Buildings; and

(2) The Department shall make available to the public on the internet and update at least annually, the following Benchmarking Information:

(a) Summary statistics on Energy consumption for Covered Municipal Buildings derived from aggregation of Benchmarking Information; and

(b) For each Covered Municipal Building individually:

(i) The status of compliance with the requirements of this Policy; and

(ii) The building address, primary use type, and gross floor area; and

(iii) Annual summary statistics, including site EUI, Weather Normalized Source EUI, annual GHG emissions, and an Energy Performance Score where available; and

(iv) A comparison of the annual summary statistics (as required by Section 5(2)(b)(iii) of this Policy) across calendar years for all years since annual reporting under this Policy has been required for said building.

#### **§5. MAINTENANCE OF RECORDS**

The Department shall maintain records as necessary for carrying out the purposes of this Policy, including but not limited to Energy bills and other documents received from tenants and/or Utilities. Such records shall be preserved by the Department for a period of three (3) years.

#### **§6. ENFORCEMENT AND ADMINISTRATION**

(1) The Director or his or her designee from the Department shall be the Chief Enforcement Officer of this Policy.

(2) The Chief Enforcement Officer of this Policy may promulgate regulations necessary for the administration of the requirements of this Policy.

(3) Within thirty days after each anniversary date of the effective date of this Policy, the Chief Enforcement Officer shall submit a report to the Genesee County Legislature including but not limited to summary statistics on Energy consumption for Covered Municipal Buildings derived from aggregation of Benchmarking Information, a list of all Covered Municipal Buildings identifying each Covered Municipal Building that the Director determined to be exempt from the benchmarking requirement and the reason for the exemption, and the status of compliance with the requirements of this Policy.

#### **§7. EFFECTIVE DATE**

This policy shall be effective immediately upon passage.

#### **§8. SEVERABILITY**

The invalidity or unenforceability of any section, subsection, paragraph, sentence, clause, provision, or phrase of the aforementioned sections, as declared by the valid judgment of any court of competent jurisdiction to be unconstitutional, shall not affect the validity or enforceability of any other section, subsection, paragraph, sentence, clause, provision, or phrase, which shall remain in full force and effect.

Budget Impact: No additional costs are associated with this new policy at this time. Potential savings may be identified by this program as energy efficiency improvements are identified. Continued monitoring of building energy usage may alert staff of problems early thus resulting in cost savings.

**BE IT ENACTED** by the Genesee County Legislature as follows:

Section 1. Section 1 of Local Law No. 1 of the year 1956 as subsequently amended, is hereby amended to read as follows:

A Self Insurance Plan as provided for in Article 5 of the Workers Compensation Law is hereby established for the County of Genesee and shall be known as the "Genesee County Mutual Self Insurance Plan," hereafter referred to as the "Plan."

Section 2. Section 2 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby amended to read as follows:

The Plan heretofore established under the provisions of subdivision 3-a of section 50 of the Workers Compensation Law of the State of New York is here continued and shall be governed by the Ways and Means Committee of the Genesee County Legislature, as provided in Article 5 of the Workers Compensation Law.

Section 3. Section 3 of Local Law No 1 of the Year 1956 as subsequently amended, is hereby amended to read as follows:

The Ways and Means Committee shall appoint an Executive Secretary of the Plan whose salary and expenses shall be payable from funds of the plan, who shall keep the necessary records of the Plan, attend hearings and transact such other business as shall be delegated to such officer by the Ways and Means Committee. The Ways and Means Committee may also employ such persons or organizations as may be deemed necessary for the operation of the Plan and may contract for the necessary actuarial or other expert or professional services. Section 4. Section 4 of Local Law No 1 of the Year 1956 as subsequently amended, is hereby amended to read as follows:

<u>Participation</u>. In addition to the County, participation in the Plan shall be available to the following municipal entities located within or partially within the County of Genesee.

Cities Towns Villages Soil Conservation Districts School Districts Genesee Community College Batavia Housing Authority Volunteer Fire Departments Public Libraries established as separate taxing entities

Section 5. Section 5 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby amended to read as follows:

Any municipal entity eligible to become a member of the Plan may become a member by filing with the Executive Secretary of the Plan, on or before the 15<sup>th</sup> day of July in any year, a certified copy of the resolution of its governing body, indicating its intention to become a participant in the Plan for the next calendar year of operation of the Plan. The Ways and Means Committee may impose fair and equitable terms and conditions to be fulfilled by such new participant as a condition precedent to acceptance as a participant in the Plan. All new plan members must sign a Plan Participant Agreement within 180 days of the adoption of Local Law No. \_\_\_\_\_\_ of the Year 2024 or within 30 days of first year joining the plan, whichever comes later. Future changes to the Plan Participant Agreement can be made by the Ways and Means Committee and must be resigned by the Plan members within 30 days of the adopted changes. Failure to sign the Plan Participant Agreement will be treated as the member effectively electing to withdraw from the plan per Section 6 below. A certified copy of the resolution of the governing body electing withdrawal shall not be required.

Section 6. Section 6 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby amended to read as follows:

Withdrawal from the Plan may be effected on or before the 15th day of July in any year by filing with the Executive Secretary of the Plan a certified copy of the resolution of its governing body electing to withdraw from the Plan at the end of the current operating year. A condition of withdrawal is the agreement of the participant to pay its proportionate share of the estimated outstanding liabilities of the Plan as determined by an actuary within ninety (90) days after the date of withdrawal. Payment of such liabilities shall be made in lump sum or the Executive Secretary may, upon approval of the Ways and Means Committee, permit said payment to be made in installments. The actuary shall determine at this time the exiting participant's share of any fund balance and a credit equal to 75% of that value will be applied against the amount due.

Section 7. Section 7 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby amended to read as follows:

For any violation of the provisions of Section 7 above or for a violation of any requirements of the Worker's Compensation Law or its underlying Rules and Regulations, by any participant, the Ways and Means Committee of the Genesee County Legislature

may assess a penalty not to exceed Five Hundred Dollars (\$500.00). Upon the recommendation of the Ways and Means Committee the Genesee County Legislature may assess a penalty in excess of Five Hundred Dollars (\$500.00) for said violation or in the alternative, expel the participant from the Plan. Any participant expelled from the Plan shall receive written notification of such expulsion at least thirty (30) days prior to the effective date of such expulsion. Expulsion from the Plan shall not relieve the participant from paying its proportionate share of the outstanding liabilities of the Plan as determined by an actuary.

Section 8. Section 8 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby amended to read as follows:

All participants in the Plan shall cooperative fully with the Executive Secretary in the administration of the Plan, reporting all accidents within 48 hours, rendering such reports as may be requested and promptly furnish all pertinent information relative to any claim. Accidents reported after 48 hours and resulting in the Plan receiving a fine will be the responsibility of the late reporting participant. In addition, participant will be subject to additional penalties as addressed in Section 7 above.

Section 9. Section 9 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby repealed.

Section 10. Section 10 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby amended to read as follows:

In the event that any Participant incurs double penalties for the illegal hiring of minors pursuant to sect 14-a of the Workers Compensation Law, said double penalties shall be the sole responsibility of the hiring participant.

Section 11. Section 11 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby amended to read as follows:

The Executive Secretary shall present to the Ways and Means Committee and the Ways and Means Committee shall approve and present to the Legislature, not later than the fifteenth day of September in each year an estimate of several amounts necessary for the ensuing calendar year a) to meet the payments with respect to the liability of participants required to be made by the county pursuant to section sixty three of the Workers Compensation Law, b) to pay the administrative expenses of the Plan, c) to repay any amounts advanced to the Plan and d) to provide for contributions to the reserve, if any.

Section 12. Section 12 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby amended to read as follows:

The Plan's expenses will be apportioned among the Plan participants on the New York State Insurance Fund calculation of a Workers' Compensation and Employers Liability total policy cost using factors and rules promulgated by the New York Compensation Insurance Rating Board and approved by the New York State Department of Financial Services, in effect on the first day of the fiscal year for which the apportionment is being made. Participants will be notified of their apportionment amounts on or before September 15th. The share of each participant in the Plan shall be billed by the Executive Secretary with payment due by January 30th.

Section 13. Section 13 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby repealed.

Section 14. Section 14 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby repealed.

Section 15. Section 15 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby repealed.

Section 16. Section 16 of Local Law No. 1 of the Year 1956 as subsequently amended, is hereby amended, to read as follows:

A reserve not to exceed the present value of the Plan's outstanding liabilities as calculated by an actuary is hereby established for the Plan.

Section 17. This local Law shall take effect upon proper filing in the office of the Secretary of State, and
