FIFTEENTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, September 8, 2021

The Genesee County Legislature met in Regular Session on Wednesday, September 8, 2021 at 5:30 PM in the Legislative Chambers of the Old Courthouse. Legislator Klotzbach was absent. Legislator Deleo offered to assist with the audit. The prayer was offered by Legislator Hawley followed by the Pledge to the Flag.

In addition to our regular meeting, Chair Stein opened a public hearing on Local Law Introductory No. 3 Year 2021 pertaining to the extension of the local law imposing a hotel/motel room occupancy tax in the County of Genesee. There were no participants in speaking during the public hearing.

Minutes of the August 25, 2021 Legislature meeting were approved upon motion of Legislator Clattenburg seconded by Legislator Dibble, carried.

Legislature Chair, Stein, commented summer is over, back to regular session. First session of budget commenced, we are back in session (2 meetings a month) and ready to work on the budget. A majority of Legislators are attending the NYSAC Conference September 13-15 thank you for holding the fort at the conference and here.

County Manager Matt Landers have recognized the first three employees of the Employees recognition program that Vicky Muckle initiated and implemented. The selected winners are placed on the Facebook page and given a certificate. Program consists of individuals of County employees that go above and beyond normal duties which the County would like to recognize. There is a pool of nominations for recognition, 15 or so nominations thus far, we randomly selected from the nominations and the first three winners are: Rachel Mieney from Mental Health, Vicki Athoe from Probation and Chelsea Elliott from the Youth Bureau. They were presented with certificates and also listed on the County's intranet. This is a way to say thank you and give back. Matt is encouraging department heads to seek out nominations and send them in. Marianne Clattenburg commented "great idea, congratulations to the people selected". RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute Amendment #1 and accept the additional funding in the amount of \$342,558.

Budget Implications: (\$342,558) will be allocated in the 2022 & 2023 budgets. Funding will be used to offset costs of COVID-19 response activities, all other COVID-19 costs over \$342,558 will be partially (36%) offset by state aid.

RESOLUTION NO. 353 AUTHORIZING AND APPROVING A SETTLEMENT AGREEMENT TO AN ACTION RELATING TO THE OPIOID CRISIS

Legislator Torrey offered the following resolution:

WHEREAS, there is pending a matter on behalf of the County of Genesee, regarding the opioid addiction crisis, in which the County of Genesee is a named plaintiff in the action (the "Action"); and

WHEREAS, the Action is against several defendants, including manufacturers of opioids, distributors of opioids and chain pharmacies; and

WHEREAS, the Action alleges several causes of action against defendants Johnson & Johnson, Janssen Pharmaceuticals, Inc., Ortho-McNeil-Janssen Pharmaceuticals, Inc. and Janssen Pharmaceutica, Inc. ("J & J") based on claims that J & J contributed to the opioid epidemic by falsely promoting prescription opioids it manufactured and sold and by falsely promoting the increased use of opioids directly and generally through various "front groups" and failing to implement measures to prevent diversion of prescription opioids in connection with distribution of its products, all of which contributed to a public health crisis in the County of Genesee; and

WHEREAS, J & J has offered to settle the claims of the County of Genesee against it by paying the sum of between approximately \$177,000 and \$413,000 over ten (10) years to be used for restitution and abatement and agreeing to not manufacture, sell or promote opioids; and **WHEREAS,** the County of Genesee has approved a settlement agreement and release

("Agreement"); and

WHEREAS, it is in the best interest of the County of Genesee to resolve this matter with respect to J & J without further litigation and enter into the proposed Agreement as it shall settle all allegations against J & J and avoid protracted litigation;

WHEREAS, the County of Genesee has retained the law firm of Napoli Shkolnik PLLC, 360 Lexington Avenue, 11th Floor, New York, NY 10017, to prosecute Opioid related claims against J&J and other defendants, and this firm has recommended the proposed settlement and. WHEREAS, the County Attorney has reviewed all of the settlement documents and also recommends the same, now there for be it

RESOLVED, that the County of Genesee Legislature does hereby approve the proposed settlement with the J&J defendants as set forth in documents provided by the Napoli Shkolnik law firm, and does hereby authorize and direct the Chair of the Legislature and the County Attorney to execute the "New York Opioid Sharing Agreement" and a "New York Subdivision Election and Release Form": together with such other documents as may be necessary and appropriate to effectuate the settlement with J&J.

Legislator Hawley seconded the resolution which was adopted by 298 votes, Klotzbach (28) absent.
