WEDNESDAY, SEPTEMBER 24, 2025**

The Genesee County Legislature met in regular session on Wednesday, September 24, 2025 at 5:30 PM in the Legislative Chambers of the Old Courthouse.

Legislator Hawley offered to assist with the audit. Legislator Clattenburg offered to assist with the prayer and the Pledge to the Flag.

Chair Stein opened a public hearing for A Local Law Introductory A of The Year 2025, Amending Local No. 3 of 2023, With Regard to The Imposition of a Mortgage Recording Tax within the County of Genesee. OPENED AT 5:32 p.m.

Roll Call was taken to establish a quorum with 9 in attendance: Legislators Stein, Klotzbach, Hawley, Dibble, Maha, Torrey, Yunker, Clattenburg and Deleo.

New national opioid settlements have been reached with Alvogen, Inc., Amneal Pharmaceuticals, Inc., Apotex Inc., Hikma Pharmaceuticals USA Inc., Indivior Inc., Mylan Pharmaceuticals Inc., Sun Pharmaceutical Industries, Inc. and Zydus Pharmaceuticals (USA), Inc., in which the County of Genesee is a named plaintiff, and

WHEREAS, the aforementioned action alleges several causes of action against distribution defendants Alvogen, Inc., Amneal Pharmaceuticals, Inc., Apotex Inc., Hikma Pharmaceuticals USA Inc., Indivior Inc., Mylan Pharmaceuticals Inc., Sun Pharmaceutical Industries, Inc. and Zydus Pharmaceuticals (USA), Inc. based upon claims that defendants contributed to the opioid epidemic by failing to comply with their obligations under the Federal Controlled Substances Act and the New York Controlled Substance Act, in order to implement adequate measures to prevent diversion of the prescription opioids that they distributed to pharmacies, all of which contributed to a public health crisis in the County of Genesee, and

WHEREAS, it is in the best interest of the County of Genesee to resolve this matter with respect to the above defendants without further litigation and to enter into a Settlement Participation Agreement and New York Sharing Agreement as it shall allow for the settlement of all allegations against the defendants and avoid protracted litigation, and

WHEREAS, the County of Genesee has retained the law firm of Napoli Shkolnik PLLC to prosecute Opioid related claims against various defendants, and said firm has recommended the proposed settlement, and

WHEREAS, the County Attorney and the Committee of Ways and Means have reviewed this request and do hereby recommend approval at this time. Now, therefore, be it

WHEREAS, it is in the best interest of the County of Genesee to resolve this matter with respect to Sandoz without further litigation and to enter into a Settlement Subdivision Participation Form/Agreement as it shall allow for the settlement of all allegations against Sandoz and avoid protracted litigation, and

WHEREAS, the County of Genesee has retained the law firm of Napoli Shkolnik PLLC to prosecute Opioid related claims against Sandoz and other defendants, and said firm has recommended the proposed settlement, and

WHEREAS, the County Attorney and the Committee of Ways and Means have reviewed this request and do hereby recommend approval at this time. Now, therefore, be it

RESOLVED, that the Genesee County Legislature does hereby approve the Settlement Subdivision Participation Form/Agreement with Sandoz as set forth in documents provided by the Napoli Shkolnik law firm, and does hereby authorized and direct the Chair of the Legislature and the County Attorney to execute a Settlement Subdivision Participation Form/Agreement, together with any and all documents as may be necessary and appropriate to effectuate the settlement with Sandoz.

WHEREAS, the Purdue/Sackler action alleges several causes of action against distribution defendant Purdue/Sackler based upon claims that Purdue/Sackler contributed to the opioid epidemic by failing to comply with their obligations under the Federal Controlled Substances Act and the New York Controlled Substance Act, in order to implement adequate measures to prevent diversion of the prescription opioids that they distributed to pharmacies, all of which contributed to a public health crisis in the County of Genesee, and

WHEREAS, it is in the best interest of the County of Genesee to resolve this matter with respect to Purdue/Sackler without further litigation and to enter into a New York Sharing Agreement and Participation Agreement related to direct settlement and avoid protracted litigation, and

WHEREAS, the County of Genesee has retained the law firm of Napoli Shkolnik PLLC to prosecute Opioid related claims against Purdue/Sackler and other defendants, and said firm has recommended the proposed settlement and execution of the Purdue Pharma L.P.'s bankruptcy plan, and

WHEREAS, the County Attorney and the Committee of Ways and Means have reviewed this request and do hereby recommend approval at this time. Now, therefore, be it

RESOLVED, that the Genesee County Legislature does hereby authorize the Chair of the Legislature and/or the County Attorney to execute any and all documents as may be necessary and appropriate to effectuate the settlement with Purdue/Sackler, including, but not limited to, a New York Sharing Agreement and Participation Agreement, and be it further

RESOLVED, that the Genesee County Legislature does hereby authorize Napoli Shkolnik PLLC, to vote on the County's behalf in favor of the Purdue Pharma L.P.'s bankruptcy plan.

Budget Impact: Funds have been transferred within the 2025 Jail budget and have been included in the 2026 Jail Budget.

WHEREAS, the Sheriff is requesting to transfer funds from the Contingency account to the Jail budget to cover the 2025 expense, and

WHEREAS, the Sheriff is requesting to transfer \$24,523 from the Contingency account to the Jail budget Contracted Medical line, and

WHEREAS, the Committees on Public Service and Ways and Means did review this request and do recommend approval. Now, therefore, be it

WHEREAS, New York State, through the enactment of the Climate Leadership and Community Protection Act (CLCPA), has established aggressive mandates and benchmarks requiring universal electrification of energy, housing, and transportation sectors; and

WHEREAS, while the goals of reducing carbon emissions and expanding renewable energy are laudable, the one-size-fits-all mandates arising from the CLCPA have created an alarming crisis in energy affordability, reliability, and local economic stability; and

WHEREAS, Genesee County is experiencing skyrocketing utility rates, escalating housing construction costs, and increased burdens on residents and businesses as a direct result of electrification mandates, including but not limited to:

- Building code requirements prohibiting the installation of natural gas hookups;
- State-imposed vehicle sales quotas that will prohibit the future sale of traditional vehicles; and
- Infrastructure benchmarks requiring widespread deployment of electric vehicle charging stations, which are neither practical nor financially feasible for many communities; and

WHEREAS, rural towns, villages, and counties in particular lack the infrastructure, energy capacity, and tax base necessary to safely and affordably implement these requirements, thereby placing disproportionate strain on municipalities already facing fiscal and operational challenges; and

WHEREAS, New York State's tradition of "home rule" recognizes the authority of local governments to make decisions that best reflect the unique needs, capacities, and interests of their residents and businesses; and

WHEREAS, local governments across the State ought to be afforded the authority to determine the pace and scope of participation in universal electrification and climate mandates, ensuring energy policy that is both practical and responsive to local conditions; and

WHEREAS, the Genesee County Legislature is in full support of the New York State Senate Bill S.8481, introduced by Senator Patrick Gallivan, which would authorize local governments to opt out of mandates and benchmarks arising under the CLCPA and associated universal electrification requirements. Now, therefore, be it

RESOLVED, that the Genesee County Legislature calls upon the New York State Legislature and Governor to enact legislation amending the Environmental Conservation Law, the Public Service Law, the Energy Law, and the Executive Law to expressly authorize local governments to opt out of mandates and benchmarks arising under the Climate Leadership and Community Protection Act and associated universal electrification requirements; and be it further

THE COUNTY OF GENESEE – APPROVAL OF**

WHEREAS, the following resolution was duly introduced to Genesee County Legislature in accordance with the Law: **LOCAL LAW INTRODUCTORY NO. A OF THE YEAR 2025, AMENDING LOCAL LAW 3 OF THE YEAR 2023 WITH REGARD TO THE IMPOSITION OF A MORTGAGE RECORDING TAX WITHIN THE COUNTY OF GENESEE**. Be it enacted, by the Legislature of the County of Genesee, State of New York as follows:

Section 1. Section 1 of Local Law 3 of the Year 2023 is hereby amended to read as follows:

Section 1. Imposition of Tax

- (a) Pursuant to Chapter 579 of the Laws of 2004, Local Law No. 3 of the year 2023 is hereby amended to end on **November 1, 2025** in accordance with Tax Law §253-K, Recording Tax imposed by the County of Genesee.
- (b) Pursuant to Chapter 579 of the **Laws of 2004 for the period beginning November 1, 2025 and ending November 1, 2027**, there is hereby imposed, in the County of Genesee, a tax of \$0.25 for each \$100.00, and each remaining major fraction thereof of principal debt of obligation which is or under any contingency may be secured at the date of execution thereof, or at any time thereafter, by a mortgage or real property situated within the County of Genesee and recorded on or after November 1, 2025 and a tax of \$0.25 on such Mortgage if the principal debt or obligation which is or by an contingency may be secured by such mortgage is less than \$100.00.

Section 2. Effective Date

This local law shall take effect on **November 1, 2025** provided a certified copy thereof is mailed by registered or certified mail to the New York State Commissioner of Taxation and Finance at least 30 days prior to such date. Certified copies of this local law shall also be filed with the Genesee County Clerk, the Secretary of State and the State Comptroller within five days after the date it is duly enacted. And,

WHEREAS, the Clerk of the Genesee County Legislature has posted a certified notice of Public Hearing on said proposed Local Law on the bulletin board in the Old Courthouse, and

WHEREAS, the Clerk of the Genesee County Legislature has published in the Batavia Daily News, the official newspaper of the County of Genesee, the notice of Public Hearing on Local Law Introductory A of the Year 2025, and

WHEREAS, a Public Hearing will be held at 5:30 on September 24, 2025 in the Legislature Chambers of the Old Courthouse, Batavia, New York, at which time all interested persons will be heard. Now, therefore, be it
