EIGHTEENTH DAY GENESEE COUNTY LEGISLATURE BATAVIA, NEW YORK WEDNESDAY, OCTOBER 27, 2021 ZOOM RECORDING AVAILABLE

The Genesee County Legislature met in Regular Session on Wednesday, October 27, 2021 at 5:30 PM in the Legislative Chambers of the Old Courthouse. Legislature Chair Stein stated, "all attending the Legislature meeting in person who are fully vaccinated more than two weeks past the date of their final shot are no longer required to wear face coverings or maintain 6-ft social distance". Legislator Hawley offered to assist with the audit. The prayer was offered by Legislator Clattenburg followed by the Pledge to the Flag.

In addition to our regular meeting, Legislature Chair Stein opened a Public Hearing on Local Law Introductory No. 4 Year 2021 - A Local Law to expand the residency Territorial Area to Employ Deputy Sheriff – Seasonals. an opened a Public Hearing on Local Law Introductory No. 5 Year 2021 - A Local Law to extend the permanent residency requirement timeframe to employ lateral transfers as Deputy Sheriffs. There were no participants in speaking during the public hearing.

Minutes of the October 27, 2021 Legislature meeting were approved upon motion of Legislator Maha seconded by Legislator Klotzbach, Carried, unanimously.

Legislator Yunker reported on Committee Report that he and Legislator Torrey and Chair Stein attended the Liberty Pumps ground breaking today. It is a 110,000 sq ft addition. Going from 300 to 350 employees. This is a great homegrown company and it was an exceptional event.

County Manager Matt Landers reported the budget was filed with the Clerk to the Legislature on Friday, October 22, 2021. The Legislature has this available to them Public Hearing on the 3rd of November for public input. Vicky Muckle is organizing the budget book and it will be available on the 3rd of November. County Manager Matt Landers reviewed highlights of the budget and thanked the Legislature and his team for working so diligently on the budget.

WHEREAS, the Committee on Ways and Means did review the proposal and does recommend approval at this time. Now, therefore, be it

This position will have State and Federal reimbursements for salary and fringe totaling approximately 72%, with the County Local cost at approximately 28% of salary and fringe.

WHEREAS, the Committees on Public Service and Ways and Means did review this request and do concur with this recommendation at this time. Now, therefore, Be it

BE IT ENACTED by the Genesee County Legislature as follows:

Section 1. Legislative Intent

The County of Genesee Legislature hereby finds that in order to ensure an adequate pool of

qualified applicants as Deputy Sheriff – Seasonals as defined herein, it is necessary and advisable that such Deputy Sheriff – Seasonals may be permitted to reside within the County of Genesee or any county contiguous to the County of Genesee.

Section 2. Definitions for the purposes of this Local Law:

a. "Deputy Sheriff-Seasonal" shall mean an active or retired Deputy Sheriff/Police Officer who shall be employed at the discretion of the Sheriff for a fixed period of time not to exceed ninety (90) days to work for a specific purpose. All Deputy Sheriff - Seasonals are required to be fully trained with New York State Police Officer certification.

Section 3. Supersede Public Officers Law

The residency provisions of Section 3(1) of the Public Officers Law and any general, special or local law, charter, code, ordinance, resolution, rule or regulations, that would require a Deputy Sheriff – Seasonal to permanently reside in Genesee County at the time of appointment is hereby superseded to allow a Deputy Sheriff – Seasonal at the time of appointment to reside in the County of Genesee or any county contiguous to the County of Genesee: namely, Erie, Niagara, Orleans, Monroe, Livingston, or Wyoming Counties.

Section 4. Severability

If any clause, sentence, paragraph, subdivision, section or part of this law, or the application thereof to any person, individual, corporation, firm, partnership, entity or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgement shall not affect, impair, effect or invalidate the remainder thereof but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this law or in its application to the person, individual, corporation, firm, partnership, entity or circumstance directly involved in the controversy in which such order or judgement shall be rendered.
