NINETEENTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, November 13, 2019

The Genesee Legislature met in Regular Session on Wednesday November 13, 2019 at 5:30 PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Young assisted with the audit. Prayer was offered by Legislator Stein followed by the Pledge to the Flag.

Minutes of the October 23, 2019 Legislature meeting were approved upon motion of Legislator Dibble seconded by Legislator Torrey, carried unanimously.

Legislator Maha stated he attended the Criminal Justice Advisory Committee meeting where it was reported that there is a lull in jail population, at present there are only 7 females. Legislator Stein announced Soil & Water Conservation District is celebrating 75 years of conservation and 1.4 million has been invested in best practices in Genesee County. Legislator Young shared that the Chamber of Commerce annual luncheon is scheduled for November 14th.

RESOLUTION NO. 408

LETTER OF INTENT – DEPARTMENT OF SOCIAL SERVICES/ NY OFFICE OF INFORMATIONAL TECHNOLOGY SERVICES – APPROVAL OF

Legislator Deleo offered the following resolution:

WHEREAS, Genesee County Department of Social Services needs to upgrade their current computer network system, and

WHEREAS, the New York Office of Informational Technology Services (NYOITS) made sight visits and determined that the need for computer network upgrades exist in Genesee County, and

WHEREAS, The Genesee County DSS has the necessary funds to cover the estimated costs for the RITM3057415 computer network upgrade request, and

WHEREAS, The Committee on Human Services has reviewed the information provided regarding this request and recommendation and does concur at this time. Now, therefore, be it

RESOLVED, That the Genesee County Legislature does hereby authorize and direct the Chairperson to accept, approve and sign the Letter of Intent and enter into an agreement with the NYOITS for the upgrade of the computer network system at the Genesee County DSS at 5130 East Main Street, Suite #3, Batavia, NY 14020 with an estimated cost of \$29,755.91.

Budget Impact Statement: Expenditures related to this agreement are eligible for Federal reimbursement up to 50% Federal aid. A budget appropriation transfer for the 2019 budget was done to cover the estimated \$29,755.91 cost for this upgrade. An ongoing annual service fee of \$19,067.00 has been included in the 2020 proposed budget. The total cost of this project is an estimate only. The actual amounts invoiced may vary from estimates and will be calculated in accordance with approved State service rates and actual utilization and/or actual costs incurred by NYOITS. Genesee County DSS obligation will include any change affecting estimated or actual costs that may arise during the fulfillment of this request.

WHEREAS, the Mental Health Director is recommending an agreement with Consilium and the County Attorney has reviewed said agreement, and

WHEREAS, The Committees on Human Services and Ways & Means did review this request and do concur. Now, therefore be it

The only potential impact to our budget is positive.

Legislator Clattenburg made a motion to suspend the rules of the Legislature to add two resolutions to the agenda. The first matter needs immediate action because an Exclusion Request Form needs to be signed on behalf of Genesee County and submitted to its litigation counsel on or before November 22, 2019. The second matter is setting three required public hearings on the Shared Services Plan that will be submitted to the Department of State by December 31, 2019 seconded by Legislator Young, carried unanimously.

RESOLUTION NO. 463 OPT OUT OF A NATIONAL NEGOTIATING CLASS REGARDING OPIOID LITIGATION

Legislator Clattenburg offered the following resolution:

WHEREAS, the County of Genesee has hired the Napoli Shkolnik, PLLC law firm to represent the County of Genesee in litigation involving damages sustained by the County as a result of the opioid epidemic, and

WHEREAS, the County's law firm has commenced a lawsuit in the Supreme Court for Genesee County, and is also representing numerous other counties and municipalities throughout New York State, and

WHEREAS, all of the litigation involving New York State counties has been coordinated in Suffolk County, and

WHEREAS, Federal Judge Polster of the United States District Court, Northern District of Ohio, has preliminarily approved a request to certify a negotiating class setting forth the framework to assist this Court to negotiate and potentially obtain a resolution of all of the opioid litigation throughout the United States, and

WHEREAS, the Napoli Shkolnik, law firm has recommended that the County of Genesee opt out of this negotiation class to continue litigation in Suffolk County, and **WHEREAS**, the County Attorney concurs with this recommendation, and

WHEREAS, to opt out of the class, a document entitled "Exclusion Request Form" needs to be signed on behalf of the County of Genesee and submitted to its litigation attorneys on or before November 22, 2019. Now, therefore, Be it

RESOLVED, that the Chair of the County of Genesee Legislature is hereby authorized and directed to execute the "Exclusion Request Form" to opt out of the negotiating class as has been recommended by the County's legal counsel in this matter. Legislator Dibble seconded the resolution which passed by 326 votes.

RESOLUTION NO. 464 SETTING PUBLIC HEARING-SHARED SERVICES PLAN
