TWENTIETH DAY GENESEE COUNTY LEGISLATURE OLD COURT HOUSE – 7 MAIN STREET, BATAVIA, NY

WEDNESDAY, DECEMBER 11, 2024

The Genesee County Legislature met in Regular Session on Wednesday, December 11, 2024 at 5:30 PM in the Legislative Chambers of the Old Courthouse.

Legislator Maha offered to assist with the audit and Legislator Deleo offered the prayer and the Pledge to the Flag.

Chair Stein called a public hearing for the proposed adoption of the modified Short Environmental Assessment Form for Agricultural & Markets for the SEQRA review and modification of Agricultural Districts and certifications opened at 5:31 p.m.

Roll Call was taken to establish a quorum with 8 legislators in attendance and 1 absence (Clattenburg) <u>Proclamations & Commendations</u>: None.

Approval of Minutes: Chair Stein approved the November 25, 2024 meeting minutes as presented.

Committee & Special Assignment Reports: None.

Communications & Petitions: None.

Legislator Comments: Chair Stein stated the water funding committee gathered to discuss waterfunding opportunities. They also talked with Environmental Facilities Corp. and New York State Department of Health. Chair Stein acknowledged the County is thankful to receive the 30 million grant and there is no plans for the county to stop at that. Chair Stein stated the Legislature continues to advocate for more funds which are needed to move forward with the phase 3 water project. Chair Stein arranged a meeting with J.W. Cook who is in the executive branch of Governor Hochul. J.W. Cook showed his commitment with scheduling a meeting quickly to discuss the needs of the County. The Legislature will continue to advocate to the State the need for water investment in Genesee County to move forward with growth.

<u>County Manager Report</u>: County Manager Matt Landers stated he was impressed with J.W. Cook and how quickly he came to tour the water plant and listen to the issues at hand. He gave good advice on financing and providing options for borrowing and feels J.W. Cook is a good asset for Genesee County. He announced Michele Nichols was nominated for the Shining Start Award; she works at GLOW and does great work. Jay Lazarony nominated her for her ability to fill in for him and her dedication to the County.

WHEREAS, The New York State Department of Environmental Conservation (DEC) has determined that the creation, modification, consolidation, termination, and certification of an Agricultural District are all actions subject to review pursuant to SEQRA, and

WHEREAS, AGM and the County wish to cooperate to the fullest extent to reduce duplication of efforts consistent with SEQRA and the Agricultural Districts Law, and

WHEREAS, the DEC has promulgated regulations pursuant to SEQRA which strongly encourage agencies to enter into cooperative agreements with other agencies regularly involved in carrying out or approving the same actions for the purposes of coordinating their procedure, and

WHEREAS, Under 617.2(m) of SEQRA, the model full and short EAFs may be modified by an agency, provided the forms remain at least as comprehensive as the model. Agencies adopting their own EAFs must follow the process set forth under 617.14(f) which requires a public hearing and filing of notice with the DEC, and
