



You can change your address online at dmv.ny.gov or at your local DMV office.

New York State (NYS) law requires you to notify DMV within 10 days of any PERMANENT address change if you have a NYS driver license, learner permit or non-driver ID card, or a NYS registration for a vehicle, boat, or snowmobile. DO NOT report a temporary address change.

You can change your address as part of the document renewal process. Complete the new address fields on your paper reminder notice, or update your address on your MyDMV account. For information about how to change your address online, visit dmv.ny.gov/address-change.

You do not have to get a new license, permit, non-driver ID card, or registration document, but you have the option to get a new document.

If you want a new document:

- 1. Complete Part 1 and Part 2 on page 2 of this form.
2. Sign your name in the "Certification" section.
3. Submit a copy (front and back) of your current valid NYS License/Permit/NDID or 6 points of proof of identity.
4. Write a check or money order made payable to "Commissioner of Motor Vehicles" for the total fee.
5. Mail the completed form and payment to: NYS DMV License Production Bureau, PO Box 2895, Albany, NY 12220-0895
6. Keep your current document(s) until you receive your new document(s) in the mail in 4 to 6 weeks. Your residential address will appear on the document.

NOTE: Personally identifiable information collected for the purpose of issuing a license or identification card may be verified against nationwide systems for accuracy. Upon issuance of a New York State credential, an out-of-state credential may be cancelled based on that issuing jurisdiction's rules, laws or regulations and even when the applicant fails to report/disclose it.

If you DO NOT want a new document:

- 1. Complete Part 1 but do not complete Part 2. DMV will update your DMV record(s) at no cost.
2. Update your address on your NYS license, permit, or non-driver ID card, and on your NYS registration document. To update your address, write your new address directly on the back of the document with permanent ink in the "Enter Address Change" box. For registrations, put a line through the old address and enter new address on the front.
3. Submit a copy (front and back) of your current valid NYS License/Permit/NDID or 6 points of proof of identity.

If you change your address and have not paid the fines for traffic violations in New York City, you must call the Traffic Violations Bureau at (718) 488-5710. Be prepared to provide your new address and pay your fines. Visit dmv.ny.gov/tickets/find-tvb-office-locations for more information.

Use the NYS Voter Registration Application to Register or Pre-Register to Vote in NYS Elections unless you decline such registration. You may also use the Registration Application to:

change your party membership
pre-register to vote if you are 16 or 17 years of age

- be a U.S. citizen
be 18 years old (you may pre-register at 16 or 17 but cannot vote until you are 18)
not be in prison for a felony conviction
not claim the right to vote elsewhere
not found to be incompetent by a court

If you are a victim of domestic violence, certain sex offenses, or stalking, you may contact the State Board of Elections before or after registering or pre-registering to vote in order to receive information regarding the address confidentiality program for victims of domestic violence and certain sex offenses. To ensure confidentiality such victims should contact the State Board of Elections before registering or pre-registering to vote.

If you decline to register to vote, the fact that you have declined to register will remain confidential and will be used only for voter registration purposes. If you sign the application and do not check the box declining to register to vote, you thereby consent to the use of any information required to complete the voter registration application. If you do register to vote, the office at which you submit a voter registration application will remain confidential and will only be used for voter registration purposes. Applying to register or declining to register to vote will not affect the amount of assistance that you will be provided by this agency. If you believe that someone has interfered with your right to register or decline to register to vote, your right to privacy in deciding whether to register or in applying to register to vote, or your right to choose your own political party or other political preference, you may file a complaint with the New York State Board of Elections, 40 North Pearl Street, Albany, NY 12207-2729 (phone: 1-800-469-6872).

Your completed application will be sent to the Board of Elections and you will be notified by your County Board of Elections when your application has been processed. If you have any questions about filling out the voter registration application or registering to vote, you should call your County Board of Elections or call 1-800-FOR-VOTE (TDD/TTY dial 711) (only for voter registration questions). If you live in New York City, you should call 1-866-VOTE-NYC. You may also find answers or tools at the New York State Board of Elections website www.elections.ny.gov
