SECOND DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, January 23, 2019

The Genesee Legislature met in Regular Session on Wednesday, January 23, 2019 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Hilchey assisted with the audit. Prayer was offered by Legislator Dibble followed by the Pledge to the Flag.

The minutes of the January 9, 2019 Legislature meeting were approved upon motion of Legislator Maha seconded by Legislator Dibble, carried unanimously.

Legislator Maha reported that the E-911 Board structure analysis was completed on the Cedar Street Tower. Icing issues have been identified and improvements are needed. All other towers are fine. State funding will be utilized for the needed improvements. Legislator Clattenburg attended the Holland Land Office Museum volunteer luncheon where members expressed appreciation for work and maintenance completed by the County. She attended the Genesee Association of Municipalities meeting where there was a lively discussion and consensus from GAM members that they are seeking written confirmation of the Legislature's intention to provide revenue disbursements for the next two years. Chairman Bausch commented he is drafting that letter. Chair Bausch stated the Jail Committee met again and will bring a recommendation for engineering/architect to the Public Service Committee next month.

Out-of-State Travel Request for Tim Hens, Highway Superintendent to travel to Washington DC for NACE Executive Committee Meeting & NaCo Transportation Steering Committee February 27 –March 6, 2019 Cost \$133.00. Motion for approval of the out-of-state travel request made by Legislator Hilchey seconded by Legislator Clattenburg, carried.

County Manager Jay Gsell commented that the State Budget has been released and will be discussed in detail at the NYSAC Legislative Conference in Albany next week. Changes to Elections have been passed by the State Legislature and include moving up Primary Elections to coincide with Federal Primary Dates and early voting. Aid to Municipalities (AIM) has been cut in this year's budget which affects all but two municipalities (Batavia City & Town of LeRoy).

The Clerk proceeded with the Resolutions:

RESOLUTION NO. 10 2018 BUDGET AMENDMENT – SHERIFF / FEDERAL ASSET FORFEITURE - APPROVAL OF

Legislator Hilchey offered the following resolution:

WHEREAS, a 2015 Ford Edge vehicle was forfeited and is being retained by the Sheriff's Office for law enforcement purposes, and

WHEREAS, pursuant to the Equitable Sharing Memorandum with the United States Marshals Service, the federal share of this vehicle is \$4,190, and

WHEREAS, in order to process the paperwork for the title of this vehicle, the U.S. Marshals Service required a check in this amount be received by December 27, 2018, and although there was not enough funds in the Forfeiture of Crime Proceeds account (A3110.2626) but there are funds in the Federal Restricted Fund Account (A899.5), and

WHEREAS, the Sheriff has requested a budget amendment to transfer funds to cover this expense, and

WHEREAS, the Committees on Public Service and Ways & Means did review this request and do recommend approval at this time. Now, therefore, be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to make the following 2018 budget amendment:

\$4,190 to Sheriff's Account A3110.2060.0000 (Vehicles)

Offset by increasing Sheriff's Revenue Account A3110.2626 (Forfeiture of Crime Proceeds) by \$4,190, with funds to come from Account A899.5 (Federal Restricted Fund)

Budget Impact: Increase in Sheriff's appropriations of \$4,190, to cover the United States Marshals Service federal share of a forfeited vehicle as a result of a Federal drug seizure, to be offset by an increase in revenue from the Federal Restricted Fund.

Legislator Dibble seconded the resolution which was adopted by 236 votes, Legislators Young (47) and Stein (43) absent.

RESOLUTION NO. 11 2019 SALARY SCHEDULE AMENDMENT-JUSTICE FOR CHILDREN ADVOCACY CENTER -APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, A Family Advocate at the Justice for Children Advocacy Center has resigned, resulting in a vacancy as of October 22, 2018 and;

WHEREAS, it has been determined that deleting this one Family Advocate position and creating a Lead Family Advocate position instead of filling this vacancy with a Family Advocate would be in the best interest of the Justice for Children Advocacy Center and the County and;

WHEREAS, The Justice for Children Program Coordinator did request an amendment in the 2019 Employee Salary Schedule in order to increase the amount of support for frontline staff and ensure the highest level of case coordination within all three JFCAC offices and;

WHEREAS, The Committees on Public Service and Ways and Means did review the request and do recommend the changes be implemented at this time. Now, therefore, Be it,

RESOLVED, That the Genesee County Treasurer and Human Resources Director are hereby authorized and directed to amend the 2019 Employee Salary Schedule by deleting one full-time, Family Advocate, Grade 9 position and adding one full-time, Lead Family Advocate, Grade 18 position effective January 24, 2019.

Budget Impact: Grants from the New York State Office of Victim Service and New York State Office of Children and Family Service fully fund this position.

Legislator Maha seconded the resolution which was adopted by 236 votes, Legislators Young (47) and Stein (43) absent.

RESOLUTION NO. 12 CONTRACT RENEWAL - JUSTICE FOR CHILDREN ADVOCACY CENTER- OFFICE CLEANING SERVICE -APPROVAL OF

Legislator Maha offered the following resolution:

WHEREAS, The Justice for Children Advocacy Center has had a contract with H2H Facility Services Inc. for cleaning services at the Batavia, Albion, and Warsaw locations since March 1, 2017; and

WHEREAS, The Justice for Children Program Coordinator has made a request to renew the contract with H2H Facility Services, Inc.; and

WHEREAS, The Committee on Public Service did review the recommendation and does concur. Now, therefore, Be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to renew the contract with H2H Facility Services, Inc., 202 W. Henrietta Rd., Suite 2A, Rochester, NY 14623 for office cleaning service at the Batavia, Albion, and Warsaw sites of the Justice for Children Advocacy Center at a monthly rate of \$505.82.

Budget Impact: Funds for office cleaning services are fully covered by grants from the NYS Office of Children and Family Services and the NYS Office of Victim Services and are already included in the 2019 Justice for Children Advocacy Center Budget.

RESOLUTION NO. 13 2018 BUDGET TRANSFER – DISTRICT ATTORNEY – APPROVAL OF

WHEREAS, The District Attorney has requested a transfer of funds in the 2018 County Budget, and

WHEREAS, The Committees on Public Service and Ways and Means did review this request and does recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to make the following budget transfer:

Budget Impact Statement: No net impact on the 2018 budget, shifting funds between expense accounts. Due to a retirement of an employee who had a family health insurance plan and the replacement of that employee with one who has a single plan, we have available funds in our Medical Account.

RESOLUTION NO. 14 2018 BUDGET TRANSFER- PUBLIC DEFENDER/ MEDICAL EXPENSE

WHEREAS, The Public Service and Ways and Means Committees did review the request and recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to transfer funds as follows:

Offset with funds to be transferred from Expense Line 4660.0000 – Contracted Other in the amount of \$788.00.

Budget Impact: There is no budget impact. Funds are being transferred within the Public Defender's Budget Legislator Dibble seconded the resolution which was adopted by 236 votes, Legislators Young (47) and Stein (43) absent.

WHEREAS, The Emergency Management Services Coordinator has deemed the 1986 Ford Fire Engine as inefficient and requests permission to declare this pumper/engine as surplus property, and

WHEREAS, The East Pembroke Fire District has gifted a 1991 Pierce Dash Fire Engine with 24,167 miles with a 1000 GMP Waterous Pump and Center Mount Pump Controls to the Genesee County Fire Training Center, and

WHEREAS, Ownership of an engine enables the county to fulfill its mission of providing safe and effective training programs mandated by the NYS Live Fire Training Policy, and

WHEREAS, The Committee on Public Service and Ways and Means did review this request and does recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature is hereby authorized and directed to accept the gifted 1991 Pierce Dash Fire Engine and to surplus the 1986 Fire Engine to be disposed of at public auction or other appropriate method.

Budget Impact Statement: None.

GENESEE/FINGER LAKES REGIONAL PLANNING COUNCIL BUDGET - FINANCIAL SUPPORT FOR 2019 -APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, Section 239c of Article 12b of the General Municipal Law authorizes that governing bodies of participating municipalities in a regional or metropolitan planning agency may collaborate with other local governments to appropriate and raise by taxation money for the expenses of such regional Planning Boards, and

WHEREAS, The Genesee/Finger Lakes Regional Planning Council has formally notified this Legislature that, under its proportional funding formula, Genesee County's 2019 share will be \$9,970 and

WHEREAS, The Committee on Public Service does recommend approval of payment of Genesee County's share at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby authorize continued participation in the Genesee/Finger Lakes Regional Planning Council and does hereby authorize and direct the County Treasurer to effect payment in the sum of \$9,970 as appropriated in the 2019 Budget, Account A8025.4660.0000.

Budget Impact: The 2019 Genesee County Budget appropriated \$9,970.00 for Contractual Services with the Genesee/Finger Lakes Regional Planning Council (Account A8025.4660.0000 Contracted-Other). This amount has remained unchanged for the last eighteen years. The Annual Report from G/FLRPC has historically shown a

significant "return" for this investment.

WHEREAS, The Genesee County Highway Superintendent has reviewed a supplemental agreement covering this work and does recommend approval at this time, and

WHEREAS, The Committee on Public Service has reviewed this request and does concur at this time, Now, therefore, be it

RESOLVED, That the Chairperson of the Genesee County Legislature is hereby authorized to approve a supplemental consultant agreement with Barton & Loguidice, 290 Elwood Davis Rd, Bo 3107, Syracuse, NY 13220 for construction inspection and administration services related to the replacement of the Pratt Road Bridge over the Tonawanda Creek in a cost not to exceed \$184,000.

Budget Impact: The supplemental agreement is for \$184,000. The capital project established for this bridge replacement has funds available for this agreement and is funded at 95% federal aid and 5% local match. Legislator Torrey seconded the resolution which was adopted by 236 votes, Legislators Young (47) and Stein (43) absent.

RESOLUTION NO. 22 CONTRACT RENEWAL – AVIATION FUEL PRODUCTS— **APPROVAL OF**

Legislator Torrey offered the following resolution:

WHEREAS, Genesee County requires a contract for the supply of aviation fuel products at the Genesee County Airport, and

WHEREAS, Genesee County has awarded an existing contract for this service that expires on February 28, 2019, and

WHEREAS, The existing contract includes options for three, one-year renewal periods, and WHEREAS, The Genesee County Highway Superintendent recommends the first one- year extension to this contract at this time, and

WHEREAS, The Committee on Public Service has reviewed this recommendation and does concur, and Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby extend the contract for the supply of aviation service products with Ascent Aviation Group, One Mill Street, Parish, NY for the period of March 1, 2019 through February 28, 2020.

Budget Impact Statement: Airport Fund includes a budgeted expense for aviation fuel with offsetting revenue. Legislator Dibble seconded the resolution which was adopted by 236 votes, Legislators Young (47) and Stein (43) absent.

WHEREAS, The Superintendent of Highways has established capital projects for the repairs of highways and bridges, and

WHEREAS, The County has been awarded a State Aid "Pass-thru" grant from the Genesee County Soil & Water Conservation District in the amount of \$18,483.37 for use with culvert replacements, and

WHEREAS, The Superintendent of Highways recommends accepting the grant funding and increasing the funding available for long span culvert replacements, and

WHEREAS, The Committees on Public Service and Ways and Means have reviewed these recommendations and does concur at this time. Now, therefore, Be it

RESOLVED, That the Chair of Genesee County Legislature is hereby authorized to execute the State Aid "Pass-Thru" agreement with the Genesee County Soil & Water Conservation District in the amount of \$ 18,483.37, and

RESOLUTION NO. 24 AWARD OF BID-2-¹/₂ TON DUMP TRUCK/ HIGHWAY

Legislator Maha offered the following resolution:

WHEREAS, The Genesee County Highway Superintendent reviewed state and local bids on dump trucks for use at the County Highway Department and does recommend awarding the bid to the lowest responsible bidder, and

WHEREAS, The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it

RESOLVED, The Genesee County Highway Superintendent is hereby authorized and directed to purchase a new and unused 2019 F-750 Dump Truck and Body from Van Bortel Ford, 71 Marsh Rd, East Rochester, NY 14445 at a cost not to exceed \$162, 897.73 as per Item #3 of the Onondaga County Contract #7974.

Budget Impact: The equipment will be purchase using 2019 Asset Acquisition Funds. Budgeted amount for this purchase is \$165,000. The total cost of the fully outfitted truck is \$162,897.73.

Legislator Clattenburg seconded the resolution which was adopted by 236 votes, Legislators Young (47) and Stein (43) absent.
