THIRTEENTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, July 11, 2018

The Genesee County Legislature met in Regular Session on Wednesday, July 11, 2018 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Torrey assisted with the audit. Prayer was offered by Legislator Maha followed by the Pledge to the Flag.

The minutes of the June 27, 2018 meeting were approved upon motion of Legislator Stein seconded by Legislator Young, carried unanimously.

Legislator Torrey reported on the brief Genesee Community College board meeting where officers were elected. Donna Ferry will serve as Chair, Peter Call Vice Chair and Jackie Whiting Secretary. The college's strategic plan update is forthcoming.

An electronic communication dated June 11, 2018 from Beth Carr was read by the Clerk. The letter referenced her request to address the full legislature concerning the matter of how a hauler may dispose of the fluids pumped from septic systems in the county and also from port-apotty business that a hauler is engaged in. Ms. Carr was invited to address the legislature where she further commented on the matter. Ms. Carr explained her involvement with a group of concerned Stafford residents who worked on getting Stafford to pass a local ordinance prohibiting the spread of this waste. She stated it is contradictory to invest money in upgrading septic systems yet allow the spread of port-a-potty and septic system waste. Ms. Carr further stated that several counties have a local law prohibiting this practice and named Erie and Monroe specifically. She stated that the cost of treating one load of waste is \$35.00. She further stated her concern with medications being flushed down toilets and then getting spread on land where it is leaching into water and soil. She referenced a research article that citied sea life on the west coast testing positive for medications. She requested the Legislature address the issue in our county. Vice Chair Clattenburg stated that she is recommending the matter be included on the next Human Services agenda. Human Services Chair Young indicated it would be included on the agenda.

County Manager Jay Gsell commented on the most recent Job Development report which has the Genesee County unemployment rate at 3.8%. A Job Fair is scheduled for July 24th which will allow local employers the opportunity to share information about open positions and necessary skills and training. He related the Governor announced the approved projects for the \$10MIL Downtown Revitalization Initiative Grant. The City of Batavia was selected to receive the grant and had to make recommendations to the Governor on which projects to fund. Vice Chair Clattenburg served on the volunteer committee and commented that there was a good balance of funding allocation.

Genesee County Jail Masonry Improvements Project; and

WHEREAS, a minimum of 25% of the project costs must be matched by cash or in-kind contributions. Now, therefore, be it

RESOLVED, that the Genesee County Legislature hereby commits to maintaining the improvements.

Budget Impact: The grant application will be up to \$500,000 to be matched by an existing capital project that is currently funded from 1% sales tax. The capital project will be further amended to reflect the new project amount and funding shares when the County is in receipt of an actual grant.

RESOLUTION NO. 263 DONATION ACCEPTANCE - LIGHTING EQUIPMENT FOR UPTON MONUMENT - APPROVAL OF

Legislator Stein offered the following resolution:

WHEREAS, The County has a policy for accepting donations of value over \$1,000, and **WHEREAS**, Lighting Design Innovations, based out of Batavia, NY, has agreed to donate lighting equipment to illuminate the Upton Monument, with said equipment having an estimated value of \$1,500, and

WHEREAS, The County budgeted \$5,000 for general grant writing services in the 2018 adopted budget, of which \$4,500 has been allocated for an EPF Historic Preservation Grant submittal for work at the old County Jail for needed stonework repairs, and

WHEREAS, The Genesee County Industrial Development Agency (GCIDA) was created by an Act of the Legislature of the State of New York on May 8, 1970 by Chapter 565 of the laws of 1970 and set forth in section 895-e of the General Municipal Law of the State of New York, and WHEREAS, The GCIDA was created by Resolution No. 177 of the Genesee County Legislature on September 23, 1970 to consist of 5 members "who shall serve at the pleasure of the Genesee County Legislature", and

WHEREAS, The membership of the GCIDA was increased by Resolution No. 225 of the Genesee County Legislature on September 19, 1979 from 5 to 7 members with "said term of office expiring at the pleasure of the Genesee County Legislature.", and

WHEREAS, member John Rizzo's term is ending June 30, 2018 and Amy Spadaro Vanderhoof completed an application requesting appointment to a seat on the seven member board of the Genesee County Industrial Development Agency, d/b/a the Genesee County Economic Development Center ("GCEDC"), and

WHEREAS, The Committee on Ways and Means does recommend Ms. Amy Spadaro Vanderhoof be appointed at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby appoint Ms. Amy Spadaro Vanderhoof of LeRoy, New York to the Genesee County Industrial Development Agency d/b/a the Genesee County Economic Development Center effective July 11, 2018 to June 30, 2024.

Budget Impact Statement: none.

Prior to the vote Legislator Young commented that Ms. Vanderhoof will be an asset to the GCEDC Board. Legislator Stein commented it is assuring to have a board member who is invested in business and the community. Vice Chair Clattenburg thanked Ms. Vanderhoof and all volunteers who serve on the multitude of County advisory and decision-making boards. Legislator Stein seconded the resolution which was adopted by 281 votes, Bausch (45) absent.

RESOLUTION NO. 267 WATER SURCHARGE INCREASE NOTIFICATION -APPROVAL OF

Legislator Stein offered the following resolution:

WHEREAS, Resolution No.120, duly adopted on April 11, 2018, did designate the County Water Master Plan which includes a plan to increase the County's current capacity by approximately 2.4 million gallons of water per day, and

WHEREAS, The County of Genesee has negotiated Amended and Restated Water Agreements with Genesee County municipalities, which will allow "Water to Pay for Water" through the collection of additional water surcharge on water users for the water system improvements, and WHEREAS, The projected water surcharge increase required for Phase 2 is approximately \$0.60 per thousand gallons of water consumed. The ultimate final rate will be determined prior to construction based on actual costs and receipt of outside aid/grants. Now, therefore, Be it **RESOLVED**, The County Legislature will increase the water surcharge from \$0.60 to \$1.20 per thousand gallons of water consumed for the planned water system improvements outlined in the County Water Master Plan for the additional 2.4 million gallons of water per day and will initiate the notification provision in the Amended and Restated Water Agreement for said increase to the City, Towns and Villages to be effective January 1, 2019.

Legislator Hilchey seconded the resolution which was adopted by 281 votes, Bausch (45) absent. RESOLUTION NO. 268 RESOLUTION URGING SUPPORT OF AN INTERNET SALES TAX BILLALLOWING ENFORCEMENT OF

SALES TAX BILLALLOWING ENFORCEMENT OF SALES TAX LAWS FOR INTERNET-BASED PURCHASES ORIGINATING IN NEW YORK STATE

Legislator Stein offered the following resolution:

WHEREAS, The Genesee County Legislature unanimously passed Resolution No. 81 *A RESOLUTION URGING THE STATE TO ENACT LEGISLATION TO ENSURE A FAIR AND LEVEL PLAYING FIELD FOR ALL RETAILERS BY ADDRESSING SHORTFALLS IN INTERNET SALES TAX COLLECTION PRACTICES* on February 28, 2018: And

WHEREAS, The recent U.S. Supreme Court ruling in South Dakota V. Wayfair, et. al. overturned a long-standing precedent set forth in the Quill decision, which required a physical presence in the state to collect the tax; And

WHEREAS, Internet-based purchases continue to grow at a much faster rate than brick and mortar retail sales; And

WHEREAS, Enacting Internet fairness and tax conformity does not create a new tax, it allows for the collection of taxes already owed; and

WHEREAS, There is a multitude of reasons why the State needs to update sales tax laws to keep pace with the current marketplace and technology and help counties survive under the mandated property tax cap as sales tax is fast becoming the second major revenue source in county budgets; and

WHEREAS, This is not a new tax, but in fact the tax is still being paid by consumers-not at point of sale but when they pay their property tax bill; and

WHEREAS, New York must move swiftly to protect its' sovereign powers and lawful prerogative against potential congressional overreach that could narrow state authority by enacting one-size-fits-all legislation; and

WHEREAS, Genesee County would benefit in the range of \$1.35million - \$2.43 million in annual sales tax local share growth which 50% is shared with our City, Towns and Villages; now therefore

BE IT RESOLVED, The Genesee County Legislature calls on the Governor and the State Legislature to effectuate an extraordinary 2018 Legislative session to submit a Program Bill that adopts the recently proposed Internet Fairness and Tax Conformity Act that considers the Supreme Court Decision and would be a more comprehensive approach; and be it

FURTHER RESOLVED, That the Legislature Clerk forward copies of this resolution to Governor Andrew M. Cuomo, New York State Senator Michael Ranzenhofer, New York State Assemblyman Steve Hawley, the New York State Association of Counties and Inter County Association urging them to act in unison and assert our State's right option.

Legislator Maha seconded the resolution which was adopted by 281 votes, Bausch (45) absent.

RESOLUTION NO. 269 APPOINTMENT-WATER RESOURCES AGENCY-APPROVAL OF

Legislator Dibble offered the following resolution:

WHEREAS, An unfulfilled term of office does exist on the Genesee County Water Resources Agency due to the unexpected and unfortunate death of long-time member William Kappus of Corfu, New York, and

WHEREAS, An application was submitted by Ms. Chris Thornley, a retired Monroe County Water Authority employee and the Ways & Means Committee does concur with this appointment Now, therefore, Be it

RESOLVED, That Ms. Chris Thornley of Corfu, New York is hereby appointed to serve the remaining term of William Kappus effective immediately through December 31, 2018.

Budget Impact: None, members serve on a voluntary basis.

Prior to the vote Legislator Dibble commented on the relevant background experience of Ms. Thornley and that her appointment to the Water Resources Agency is timely given the planning and work on water and meeting community demands that lie ahead of the Agency and County. Legislator Stein echoed those comments and stated the County is fortunate to have a volunteer with her breadth of knowledge. Vice Chair Clattenburg restated her thanks to those residents who willingly share their time and talent with the County by serving on boards and committees. Legislator Maha seconded the resolution which was adopted by 281 votes, Bausch (45) absent.
