TWENTITH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, November 28, 2018

The Genesee County Legislature met in Regular Session on Wednesday, November 28, 2018 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Hilchey conducted the audit. Prayer was offered by Legislator Clattenburg followed by the Pledge to the Flag.

The minutes of the November 14, 2018 Legislature Meeting were approved upon motion of Legislator Maha seconded by Legislator Clattenburg, carried.

Mr. Glen Adams signed up to speak and was offered the floor to state his support of the Second Amendment and his request for legislators to support the resolution on the agenda. The resolution is Genesee County Legislature Reaffirms Support of the Second Amendment. Chair Bausch thanked Mr. Adams and the other residents for attending the Legislature meeting and having their voice be heard.

Legislator Stein stated the Jail Committee is scheduled to meet tomorrow (11/29/18). The Committee interviewed two engineer/architects and will be reviewing the presentations and notes on each firm. A tour of the Jail was offered to GAM members prior to the last GAM meeting and five people attended. She also reported that a Sales Tax Committee of GAM is formed and they are reviewing proposals and recommendations. Inter County Association was held in Wellsville however due to weather there were not enough for a quorum. Genesee County is hosting Inter County in April 2019. Also noted was the Johnson Controls update recently provided by Highway Superintendent Tim Hens.

An Out-of-State Travel Request for Joseph Graff of the Sheriff's Office to travel to Quantico, VA for FBI National Academy from January 7-March 15, 2019 at a county cost of \$1,235 was approved upon motion of Legislator Hilchey seconded by Legislator Stein, carried unanimously.

Legislator Stein stated that she will recuse herself from the Soil & Water Conservation District Manager search and selection process. Chairman Bausch stated that the resolutions passed at the November 14, 2018 Legislature Meeting relating to change in sales tax distribution and revenue distribution payments have been sent to all towns and villages.

The Clerk proceeded with the resolutions:

RESOLUTION NO. 410 BUDGET AMENDMENT - DISTRICT ATTORNEY 2018-APPROVAL OF

Legislator Maha offered the following resolution:

WHEREAS, the District Attorney has requested an amendment to the 2018 County Budget to allow for utilization of a portion unexpended forfeiture funds in the amount of \$193.00 and the Committees on Public Service and Ways & Means concur. Now, therefore, Be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to amend the 2018 Genesee County Budget by increasing District Attorney Appropriation

A.1165.2010.0021 Tables/Tubs/Totes in the amount of \$193.00 to be offset by an increase in District Attorney Revenue A1000.1165.2626.0000 Forfeiture of Crimes in the amount of \$193.00.

Budget Impact Statement: Increased expense for the District Attorney's 2018 budget of \$193.00 which is totally offset by using funds allocated for the District Attorney's Office in a Forfeiture of Crimes proceeds.

Legislator Young seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 411

ACCEPTANCE OF GRANT FUNDS - STATEWIDE INTEROPERABLE COMMUNICATIONS GRANT -SHERIFF - APPROVAL OF

Legislator Maha offered the following resolution:

WHEREAS, The New York State Division of Homeland Security and Emergency Services Office of Interoperable and Emergency Communications has awarded Genesee County sustainment funds in the amount of \$664,778.00 from the Statewide Interoperable Communications Grant program, and

WHEREAS, The grant funds can be used for a variety of reimbursements including, but not limited to: currently budgeted operational costs such as radio system maintenance, tower leases, radio system utilities; new equipment purchases such as additional radio infrastructure improvements, programming, and interoperable user equipment; and a portion of currently budgeted salary expenditures, and

WHEREAS, The grant period is from January 1, 2019 – December 31, 2020, and

WHEREAS, The Sheriff is requesting acceptance of these grant funds, and

WHEREAS, The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now, therefore, be it

RESOLVED, That the Chair of the Legislature is hereby authorized and directed to accept the Division of Homeland Security and Emergency Services Office of Interoperable and Emergency FY2018 Statewide Interoperable Communications Formula Grant in the amount of \$664,778.00. **Budget Impact: None.** The funds will be used for capital projects or short-term projects addressed via budget amendment.

Legislator Dibble seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 412 ACCEPTANCE OF GRANT FUNDS-BUDGET AMENDMENT/SHERIFF – EMERGENCY PREPAREDNESS EXERCISES – APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, the Sheriff requested authorization to accept grant funding from the NYS Division of Homeland Security and Emergency Services, in the amount of \$3,548, to participate in emergency preparedness exercises, and

WHEREAS, the Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to amend the 2018 budget as follows:

\$2,711 to A3110.1010.0000 (Personal Services)
\$164 to A3110.8010.0000 (Social Security Tax)
\$38 to A3110.8011.0000 (Medicare Tax)
\$635 to A3110.8020.0000 (Retirement)
to be offset by an increase in revenue account A3110.4305.2 (Federal Aid/Homeland Security) in a like amount.

Budget Impact Statement: Increase in Sheriff's appropriation of \$3,548, from NYSDHSES grant funding to participate in emergency preparedness exercises, offset by an increase in revenue in a like amount.

Legislator Stein seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 413 BUDGET AMENDMENT - SHERIFF'S OFFICE / PURCHASE OF POLICE K-9 AND EQUIPMENT -APPROVAL OF

Legislator Hilchey offered the following resolution:

WHEREAS, Genesee County Sheriff's Office police K-9, Destro, died in early October, and a fundraising campaign was initiated to assist with the costs associated with continuing the program and purchasing a new police K-9, and

WHEREAS, Deputy Erion has agreed to continue to be the K-9 handler and has selected a new K-9 for purchase at a cost of \$8,500, which includes shipping and customs fees, with additional equipment /supplies and a health physical for the K-9 at a cost of \$1,000, and the total cost being \$9,500, and

WHEREAS, the Sheriff is requesting a budget amendment to use the money donated to the Genesee County K-9 Fund to cover these costs, and

WHEREAS, the Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

RESOLVED, that the Genesee County Treasurer is hereby authorized and directed to amend the 2018 budget by increasing Sheriff's Account A3110.4800.3317 (Program Expense – Canine Program) by \$9,500, to be offset by an increase in revenue account A3110.2705 (Gifts and Donations) of \$9,500.00.

Budget Impact Statement: Increase in Sheriff's appropriations of \$9,500 for the purchase of a K-9, a health physical for the K-9, and related equipment and supplies, to be offset by an increase in revenue from gifts and donations to the Genesee County K-9 Fund.

Prior to the vote Legislator Hilchey commented on the out-pouring of community support and that the Legislature is appreciative. The dog is presently driving around with Deputy Chris Erion and will be further assessed and trained.

Legislator Deleo seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 414 REAPPOINTMENT / TRAFFIC SAFETY BOARD – SHERIFF – APPROVAL OF

Legislator Dibble offered the following resolution:

WHEREAS, the term for current Traffic Safety Board member Donna Hackett will expire November 30, 2018, and she has expressed a desire to be reappointed, and

WHEREAS, the Committees on Public Service and Ways & Means do recommend reappointing Ms. Hackett to an additional three-year term effective December 1, 2018, through November 30, 2021; Now, therefore, be it

RESOLVED, that the three-year reappointment of Donna Hackett for the Genesee County Traffic Safety Board is approved at this time.

Budget Impact: None.

Legislator Clattenburg seconded the resolution which was adopted by 326 votes.

WHEREAS, the Public Service Committee did review the contract for grants amendment and does recommend acceptance at this time. Now, therefore, Be it

Budget Impact: Increase to 2018 budget expense in amount of \$500 - offset by revenue in like amount. Cost to County \$0.

RESOLUTION NO. 422 2018 BUDGET TRANSFER – HIGHWAY – COUNTY ROAD FUND (SNOW & ICE)

Legislator Maha offered the following resolution:

WHEREAS, The County depleted its budgeted amount for the purchase of road salt within the 2018 County Road budget, and

WHEREAS, The County Superintendent of Highways has recommended transfer to the 2018 County Road budget in order to purchase additional salt for the treatment of snow and ice on the highways, and

WHEREAS, The Committees on Public Service and Ways and Means did review this recommendation and concur at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to amend the 2018 County Road budget through intrafund transfer by increasing Salt (D5142.4800.1005) in the amount of \$40,000.00 and decreasing Oil & Stone (D5110.4800.1001) in the amount of \$40,000.00.

Budget Impact: This is a transfer within divisions of the County Road Fund.

Legislator Deleo seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 423 AWARD OF BID– PRATT ROAD BRIDGE OVER TONAWANDA CREEK – HIGHWAY -- APPROVAL OF

Legislator Dibble offered the following resolution:

WHEREAS, Genesee County has been awarded a BRIDGE-NY grant and desires to replace the Pratt Rd Bridge over the Tonawanda Creek, and

WHEREAS, Genesee County advertised bid specifications for the construction of this project and received several competitive bids, and

WHEREAS, The Genesee County Highway Superintendent has reviewed the bids to determine the lowest responsible bidder, and

WHEREAS, The Committee on Public Service have reviewed these recommendations and do concur at this time,

Now, therefore, be it

RESOLVED, That the Chairperson of the Genesee County Legislature is hereby authorized to execute a contract with Union Concrete and Construction Co., 105 Center Rd., West Seneca, NY 14224 in the amount of \$1,589,876.60 for the construction and replacement of the Pratt Road Bridge over the Tonawanda Creek in the Town of Pembroke.

Budget Impact: The award total is \$1,589,876.60 which will be funded from the capital project established for this project.

Legislator Maha seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 424

REQUEST FOR THE MONROE COUNTY WATER AUTHORITY TO ISSUE BONDS ON BEHALF OF GENESEE COUNTY – COUNTYWIDE WATER PROJECT PHASE 2 – APPROVAL OF

Legislator Stein offered the following resolution:

WHEREAS, Genesee County has an Amended and Restated Water Development and Supply Agreement with the Monroe County Water Authority "Authority"; and

WHEREAS, Article 2 of the Amended and Restated Water Development and Supply Agreement do permit the Authority to issue Authority Obligations on behalf of Genesee County; and

WHEREAS, Under the same, Genesee County is required to pay for the cost of borrowing and future debt service on the Authority Obligations; and

WHEREAS, Genesee County has entered into intermunicipal agreements relative to the collection of additional water surcharge and revenue sharing among the municipalities of the

County in order to fund all costs related to Authority Obligations issued on behalf of the County, and

WHEREAS, Genesee County has completed a Master Plan and Engineering Report that identifies water supply projects needed under Phase 2 of the Countywide Water Program to add up to 2.4 million gallons a day of additional water supply, and

WHEREAS, The projects required under Phase 2 to be financed by the Authority are estimated not to exceed \$20 million, and

WHEREAS, The Genesee County Water Resources Agency has reviewed these plans and estimates and does recommend that the Genesee County Legislature request the Authority to issue debt on the behalf of Genesee County so that these projects may be undertaken, and

WHEREAS, The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby formally request the Authority to issue up to \$20 million in Authority Obligations on the County's behalf so that projects identified under Phase 2 of the Countywide Water Program may be funded as per the requirements of the Amended and Restated Water Development and Supply Agreement between Genesee County and the Monroe County Water Authority.

Budget Impact: Based on a \$20,000,000 borrowing for 30 years at 4%, the annual debt service would be \$1,156,602. The estimated water surcharge collection based on an additional \$0.60 per thousand gallons and increasing demand puts additional water fund revenue at \$1,211,070, which is enough for the County to cover the new bonding costs.

Legislator Torrey seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 425

CONSULTANT AGREEMENTS – SEQR/MASTER PLANNING AND PRELIMINARY ENGINEERING SERVICES – COUNTYWIDE WATER PROJECT PHASE 3 AND WEST SIDE WATER SUPPLY – APPROVAL OF

Legislator Maha offered the following resolution:

WHEREAS, Genesee County has completed a Master Plan and Engineering Report that identities water supply projects needed under Phase 2 of the Countywide Water Program to add up to 2.4 million gallons a day of additional water supply, and

WHEREAS, Additional water supply is needed to support the long term growth of the Countywide Water System as well as the replacement of the City of Batavia Water Treatment Plant, and

WHEREAS, The Genesee County Water Resources Agency has reviewed proposals from CPL Team for the planning, engineering and environmental work needed to jump start Phase 3 and does recommend that the Genesee County Legislature approve consultant agreements at this time, and

WHEREAS, The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby authorize and direct the Chair of the Genesee County Legislature to enter into two consultant agreements with CPL Team for Master Planning and Preliminary Engineering and SEQR for a total of \$550,000.

Budget Impact: Total costs of contracts are \$550,000. It is anticipated that these contracts will be funded with locally bonded projects under Phase 2.

Legislator Deleo seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 426 2018 BUDGET TRANSFER- DISTRICT ATTORNEY – APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, There is currently a shortage in funds in the District Attorney's, Court Reporter account due to a significant increase in Grand Jury cases, and

WHEREAS, There are not enough funds available within the accounts to cover the expenses and the County Manager recommends using the 2018 General Contingency Fund, and

WHEREAS, The Public Services Committee and Ways and Means Committee did review this request and does recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to make the following 2018 budget transfers:

\$5,500.00fromA.1990.4800.0000Contingency, Program Expense\$5,500.00toA.1165.4640.0015District Attorney, Court Reporter-T/V

Budget Impact: The 2018 General Fund Contingency has sufficient funds to accommodate this transfer and keep these accounts from going into the red for the remaining in the fiscal year. Contingency Balance after transfer = \$32,353. Legislator Clattenburg seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 427 GENESEE COUNTY LEGISLATURE REAFFIRMS SUPPORT OF THE SECOND AMENDMENT

Legislator Hilchey offered the following resolution:

WHEREAS, The Genesee County Legislature has gone on record unanimously opposing New York States infringement on an individual's Second Amendment "Right of the people to keep and Bear Arms", and

WHEREAS, Resolution No. 65-2013 MEMORIALIZATION CALLING FOR THE REPEAL OF THE SAFE ACT OF 2013 was adopted and sent to the President, Governor and other lawmakers as well as to Inter County Association and NYSAC, and

WHEREAS, This Genesee County Legislature will continue to oppose any infringement on the 2^{nd} Amendment such as, but not limited to, long-gun/hunting/sporting gun registry or Firearm Owner Identification Card (FOID card) and/or requiring gun owners to purchase insurance for each gun legally owned, now, therefore, be it
