TWENTY-FIRST DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, December 12, 2018

The Genesee County Legislature met in Regular Session on Wednesday, December 12, 2018 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Dibble assisted with the audit. Prayer was offered by Legislator Maha followed by the Pledge to the Flag.

In addition to our regular meeting Chairman Bausch opened a Public Hearing on Local Law Introductory No. 7 Year 2018, A Local Law in Relation to the Salaries of County Officers of the County of Genesee, Elected or Appointed for a Fixed Term. No one spoke on the matter.

The minutes of the November 28, 2018 Legislature meeting were approved upon motion of Legislator Maha seconded by Legislator Deleo, carried unanimously.

Legislator Hilchey, also a legislative liaison to the Soil & Water Conservation District Board, reported that Brad Mudrynski of Elba has been hired as the District Manager. Legislator Young, liaison to the Chamber of Commerce announced the Chamber is seeking nominations for their annual awards which cover several categories and are given out in March of each year.

County Manager Jay Gsell announced that Sheriff Sheron is the new chair of the Criminal Justice Advisory Council (CJAC). The Committee met today and there was lively discussion on opioid overdose issues as well and marijuana and possible legalization in New York State. Chairman Bausch commented on the Colorado report and the number of arrests and impact on the criminal justice and legal system in that state.
