### FIFTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, March 8, 2017

The Genesee County Legislature met in Regular Session on Wednesday, March 8, 2017 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Bausch assisted with the audit. Prayer was offered by Legislator Young followed by the Pledge to the Flag.

The Clerk reported that the Reality Check youth scheduled to receive a Kick Butts Day Proclamation were unable to attend the meeting due to adverse weather.

The minutes of the February 22, 2017 meeting were approved upon motion of Legislator Stein seconded by Legislator Young, carried unanimously.

Legislator DeJaneiro stated that he attended the Water Resources Agency meeting where survey results were reviewed by the consultant providing useful information to the board. Legislator Bausch reported on the Rochester Regional Transit Authority meeting where discussion regarding the difficulty with integrating bus service between Genesee and Orleans Counties. He went on to state that the Methadone Clinic discussion that began at the Human Services Committee meeting last week continued at the CJAC meeting he attended earlier in the day. Legislator Deleo explained that he met with a constituent who was having difficulty completing the Safe Act recertification so the OFA was contacted. NY Connect is a program that will assist seniors with completing forms. Chairman Cianfrini announced that he and County Manager Jay Gsell are scheduled to meet with Orleans County officials to begin the discussion about a combined jail.

The Clerk stated that correspondence was received from Assemblyman Hawley acknowledging the supporting resolution sent to his office. He is a sponsor of A3397 which increases the county share of DMV revenue providing a more equitable share for counties. NYSAC sent a letter acknowledging receipt of Resolution 48 which calls for an extension of the Mortgage Tax Increase and Resolution 49 calling for a continuation of the 1% sales tax.

An Out-of-state travel request for Tim Hens, Highway Superintendent to attend NACE Annual Conference & Expo 4/7-4/13/17 Cincinnati, OH cost to county \$746 was approved upon motion of Legislator Bausch seconded by Legislator Torrey, carried unanimously.

Legislator Stein commented that two county employees, Steve and Lisa Grice were honored as Geneseeans of the Year by the Chamber of Commerce. They have contributed their time and talents generously to local non-profits. Chairman Cianfrini noted that Stein Farms was selected as the Agricultural Business of the Year, a well-deserved honor for Legislator Stein and her family-run farm operation.

County Manager Jay Gsell explained there have been two rounds of funding by New York State for rural broadband and new partnerships between the public and private sector. They want to extend into underserved areas throughout the state. Genesee is looking into working with Livingston County as well as establishing a partnership with a private entity.

**Budget Impact:** None. Expenses are fully funded with the \$5,002 in deferred federal revenue already received in 2016 and being incorporated into the 2017 budget.

**RESOLVED**, That the County Treasurer is authorized to amend the 2017 A 4010 budget to reflect the increase in the amount of \$10,436 in A 4010.4401.20.

**Budget Impact:** Revenue and expenses, in the amount of \$10,436 will be appropriated to the 2017 4010 Health Dept. budget. There is no county cost to this program.

**WHEREAS,** The Genesee County Manager, Human Resources Director, Executive Assistant to the County Manager and Purchasing Director did review proposals received and have recommended that the services of Premier Consulting be retained as the County's health benefits plan consultant, and

**WHEREAS**, The Committee on Ways and Means has reviewed this recommendation and does concur. Now, therefore, be it

**RESOLVED**, That the Chair of the Genesee County Legislature be and hereby is authorized and directed to execute an agreement with Premier Consulting, 1416 Sweet Home Road, Amherst, New York to provide Health Benefits Plan Consulting services at a cost of \$45,000 per year with said contract to commence February 1, 2017 through January 31, 2018 with the option for four additional one year renewals upon written mutual agreement of the parties.

Budget Impact Statement: Funds are budgeted in the 2017 Health Plan budget for this cost.
