#### TWELVTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, June 28, 2017

The Genesee County Legislature met in Regular Session on Wednesday, June 28, 2017 at 5:30PM at the Old Courthouse, 7 Main Street, Batavia, New York. Legislator Davis assisted with the audit. Prayer was offered by Legislator DeJaneiro followed by the Pledge to the Flag.

The minutes of the June 14, 2017 legislature meeting were approved upon motion of Legislator Stein seconded by Legislator Young, carried unanimously.

Legislator Stein reported at Inter County Association meeting NYSAC provided updates on the Raise the Age Taskforce which consists of commissioners of departments affected will be hosting regional meetings later this summer. Also shared was that the indigent defense taskforce is created and the state pays for it however, it won't go into place until it's funded through the budget.

County Manager Jay Gsell provided an update on what is being reported from the Extraordinary Session called by the Governor. The Session started mid-day today with a Leaders conference to discuss agenda items in addition to the Mayoral control of NYC schools. The Senate was demanding the tax extenders be included however, no votes or action has been taken as of 5:30 PM.

The Clerk proceeded with the Resolutions:

#### RESOLUTION NO. 229 GRANT AWARD-GENESEE JUSTICE/NYS DIVISION OF CRIMINAL JUSTICE SERVICES-APPROVAL OF

Legislator Davis offered the following resolution:

**WHEREAS,** The Program Coordinator of the Genesee Justice Program did receive notification of the award of grant funding from the New York State Division of Criminal Justice Services for the continuation of the Community Service Sentencing Program and the Pre-Trial Services Program for a one-year contract term starting July 1, 2017 through June 30, 2018, and

**WHEREAS**, The Public Service Committee did review and does recommend acceptance of the grant funding at this time. Now, therefore, Be it

**RESOLVED,** That the Genesee County Legislature does hereby accept grant funding from the New York State Division of Criminal Justice Services in the amount of \$41,876 for the continuation of the Community Service Sentencing Program and the Pre-Trial Services Program for 2017-2018, and Be it further,

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary form for the acceptance of funds for the period of July 1, 2017 through June 30, 2018 in the amount of \$41,876.

**Budget Impact:** There is a minimal grant reduction to A 3151 3320 (State Aid-Community Service - CSS \$34,978) and A 3151 3310.31 (State Aid-ATI – ATI \$6,898). These monies are being offset with a donation from the Genesee County Bar Association. There is no amendment for the 2017 County Budget.

Legislator Clattenburg seconded the resolution which was adopted by 288 votes, Torrey (38) absent.

**WHEREAS,** The Genesee County Public Defender's Office does recommend the Public Defense Case Management System Maintenance and Software Agreement between Genesee County Public Defender's Office and New York State Defenders Association, Inc. contract be extended for a period through May 3, 2018, And

**WHEREAS,** The Public Service Committee did review and does recommend the contract extension. Now, therefore, Be it

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary documents to extend the contract for the provision of the Public Defense Case Management System Maintenance and Software Agreement between Genesee County Public Defender's Office and New York State Defenders Association, Inc., Albany, New York for the period of May 3, 2017 through May 3, 2018 for a total cost of \$2,500.00. **Budget Impact:** Funds for this contract are budgeted in the 2017 budget.

**WHEREAS**, The bid did meet specifications, and the Sheriff does recommend that the bid for the purchase of five law enforcement vehicles be awarded to Beyer Ford, for a total purchase price of \$122,502.50, with authorization to trade-in the following four vehicles, and

#### ADOPTION OF BY-LAWS & APPOINTMENT OF EX-OFFICIO MEMBERS – SHERIFF'S OFFICE/ ENHANCED 9-1-1 OPERATIONS BOARD – APPROVAL OF

Legislator Clattenburg offered the following resolution:

**WHEREAS**, The Enhanced 9-1-1 Operations Board was established by the Genesee County Legislature on June 22, 2005, pursuant to Resolution 204 (see attached), and

**WHEREAS**, a draft of the by-laws was created and reviewed by the Enhanced 9-1-1 Operations Board, and a decision to appoint the Director of Emergency Communications as an ex-officio member was agreed upon, and

**WHEREAS**, The board members have since been operating according to these by-laws, however, it has come to light that a final version of the by-laws and the ex-officio member

appointment of the Director of Emergency Communications were not officially adopted by the Genesee County Legislature, and

**WHEREAS**, there is a need for revisions to the by-laws and a desire to appoint the Director of Information Technology as an ex-officio member to the Enhanced 9-1-1 Operations Board, and **WHEREAS**, after careful review by the members of the Enhanced 9-1-1 Operations Board and the County Attorney, I am requesting the "revised" by-laws and ex-officio appointments of the Directors of Emergency Communications and Information Technology be officially adopted by the Genesee County Legislature, and

**WHEREAS**, the Committees on Public Service & Ways and Means did review this request and do recommend approval at this time. Now, therefore, be it

**RESOLVED**, that the Genesee County Legislature hereby approves the "revised" Enhanced 9-1-1 Operations Board By-Laws and be it also

**RESOLVED,** that the Genesee County Legislature approves the appointments of the Directors of Emergency Communications and Information Technology as ex-officio members of the Enhanced 9-1-1 Operations Board.

**BUDGET IMPACT**: There is no impact. Members of this Board serve without compensation.

#### MAINTENANCE AGREEMENT RENEWAL & BATTERY REPLACEMENT / BUDGET AMENDMENT -SHERIFF'S OFFICE / EATON CORPORATION UNINTERRUPTED POWER SUPPLY - APPROVAL OF

Legislator Young offered the following resolution:

**WHEREAS**, Genesee County did contract with Eaton Corporation, represented by Lynn Associates, Inc. 6622 Main Street, Suite 4, Buffalo, New York 14221 for the purchase, installation and maintenance of the Uninterrupted Power Supply (UPS) supporting the Genesee County Emergency Dispatch Center at 165 Park Rd, Batavia, NY 14020 pursuant to Resolution #292 on August 13, 2014, and

**WHEREAS**, the current three-year maintenance agreement will expire on July 26, 2017, and the UPS batteries require replacing every five years; and

**WHEREAS**, Genesee County received a NYS Statewide Interoperable Communications Grant which included funds for radio system maintenance, and

**WHEREAS**, Eaton Corporation and the County negotiated a three-year maintenance agreement renewal with an annual cost of \$5,570.00 each year plus the purchase of replacement batteries at a one-time cost of \$18,010.98, and

**WHEREAS**, After careful review by the Genesee County Sheriff, County Attorney, and Director of Emergency Communications, we recommend the County renew the maintenance agreement with Eaton Corporation for the period of July 27, 2017, through July 26, 2020, at a cost not to exceed \$16,710.00, to be paid in three annual payments of \$5,570.00, and approve the purchase of replacement batteries at a one-time cost of \$18.010.98, and

**WHEREAS**, The Committees on Public Service and Ways & Means did review this request and do recommend approval at this time. Now therefore be it

**RESOLVED**, that the Chair of the Genesee County Legislature authorizes and directs the Sheriff to sign the three-year renewal maintenance agreement with Eaton Corporation for the period of July 27, 2017, through July 26, 2020, at a cost not to exceed \$16,710.00, to be paid in three annual payments of \$5,570.00 and to approve the purchase of replacement batteries at a one-time cost of \$18.010.98; and be it further

**RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to amend the 2017 budget by increasing Sheriff's Communications appropriations as follows:

**Budget Impact:** Increase in Sheriff's Communications appropriations in the amount of \$23,581.00, to be offset by an increase in revenue in a like amount, with funds to come from NYS Statewide Interoperable Communications Grant funding.

**WHEREAS,** the Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature is hereby authorized to request Resolution #175-2016 be amended to reflect the correct term of July 1, 2016, through June 30, 2018.

**BUDGET IMPACT**: *There is no budget impact for this amendment.*

WHEREAS, Genesee County desires to upgrade the video wall's monitors to LED Engines, and WHEREAS, Activu provided a quote for the upgrades in the amount of \$84,997.81 per New York State OGS Contract, and

**WHEREAS,** The Genesee County Sheriff, County Attorney, and Director of Emergency Communications recommend a contract be approved for a cost not to exceed \$84,997.81, and

**WHEREAS,** The Committee on Public Service did review this request and does recommend approval at this time. Now therefore be it

**RESOLVED,** That the Chair of the Legislature is hereby authorized and directed to enter into an agreement with Activu, 301 Round Hill Drive, Rockaway, NJ 07866 for the upgrade of the Network Interface Display Monitor for a total cost not to exceed \$84,997.81, to be offset by revenue from the NYS Statewide Interoperable Communications Round 4 Grant.

**Budget Impact:** The total cost this project, \$84,997.81, will be offset by funds from the NYS Statewide

*Interoperability Grant Round 4 Funds currently allocated in the 800 MHz Radios System Upgrade capital project.* Legislator Davis seconded the resolution which was adopted by 288 votes, Torrey (38) absent.

#### INTER-AGENCY AGREEMENT REVISION – SHERIFF'S OFFICE / PUBLIC SAFETY RADIO SYSTEM – APPROVAL OF

**WHEREAS,** An Inter-Agency Agreement (IAA) was created for public safety and public service agencies to enter into in order to utilize Genesee County's 800 MHz Radio System, and was approved by the Genesee County Legislature pursuant to Resolution #29 on January 22, 2014 (see attached), and

**WHEREAS,** After discussion between the Sheriff, County Attorney, District County Attorney, County Emergency Management Coordinator and the Director of Emergency Communications, it is recommended that revisions be made to the original IAA to better suit the needs of the requesting users and Genesee County, and

**WHEREAS**, the Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature is hereby authorized and directed to enter into an agreement with public safety and public service user agencies of the County's Public Safety Radio System utilizing the revised Inter-Agency Agreement.

**BUDGET IMPACT:** There is no budget impact with approval of this Inter-Agency Agreement. Legislator DeJaneiro seconded the resolution which was adopted by 288 votes, Torrey (38) absent.

**RESOLUTION NO. 237** 

#### AGREEMENT RENEWAL AND BUDGET AMENDMENT – SHERIFF / POLICE SERVICES FOR VILLAGE OF BERGEN - APPROVAL OF

Legislator Bausch offered the following resolution:

**WHEREAS**, the Village of Bergen's contract for additional police services for the Village expired May 31, 2017, and it has requested to renew its agreement to commence June 1, 2017, through May 31, 2018, and

**WHEREAS**, the current Genesee County Deputy Sheriffs' Association Labor Agreement expired December 31, 2016, and the 2018 retirement and mileage rates will not be available until late 2017, and the Village of Bergen has been made aware that these rates will change, and it will be billed separately for the difference, and

**WHEREAS,** the Sheriff does recommend entering into a renewal agreement, and the Committees on Public Service and Ways & Means do concur. Now, therefore, be it

**RESOLVED**, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute the renewal agreement by and between the Village of Bergen and the Genesee County Sheriff's Office for a period commencing June 1, 2017, through May 31, 2018, and be it further

**RESOLVED**, that the Genesee County Treasurer is hereby authorized and directed to amend the 2017 budget by increasing Sheriff's account A3110.1020.0900 (Overtime - Bergen Patrols) in the amount of \$13,500, to be offset by an increase in revenue account A3110.2804.1 (Shared Services-Additional Police Services) in a like amount.

**Budget Impact**: Appropriation of \$13,500 offset by revenue billed back to entities for additional law enforcement services.

#### RESOLUTION NO. 238 MOU RENEWAL – SHERIFF / BYRON-BERGEN SCHOOL RESOURCE OFFICER - APPROVAL OF

WHEREAS, Reimbursement from Byron-Bergen Central School District will include the hourly rate for a grade 12/step 3 Deputy Sheriff, fringe benefits and insurances in the amount of \$108,660.94\*, and

\* The Genesee County Deputy Sheriffs' Association 2014-2016 contract expired on December 31, 2016, and the hourly rate will not be known until the Collective Bargaining Agreement is ratified. In addition, the yearly retirement rate is not available until late fall of each year; therefore, the 2018 reimbursement rate will change. As a result, this rate will be modified, and, if applicable, the difference will be billed under a separate invoice.

WHEREAS, after careful review by the Sheriff and County Attorney, and

**WHEREAS**, the Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED**, that the Chair of the Genesee County Legislature and Genesee County Sheriff are authorized to sign this MOU.

**Budget Impact:** Costs for the Byron-Bergen School Resource Officer are offset by revenue in the same amount.

**RESOLVED**, That the Genesee County Legislature does hereby authorize and direct the Genesee County Treasurer to make the following amendments to the 2017 Budget:

**Budget Impact**: Insurance proceeds of \$4,381.00 will be used to offset the expenses within the Facility Maintenance budget.

**WHEREAS,** The County has been awarded a State Aid "Pass-thru" grant from the Genesee County Soil & Water Conservation District in the amount of \$83,247.21 for use with culvert replacements, and

**WHEREAS**, The Committees on Public Service and Ways and Means have reviewed these recommendations and does concur at this time. Now, therefore, Be it

**RESOLVED,** That the Chair of Genesee County Legislature is hereby authorized to execute the State Aid "Pass-Thru" agreement with the Genesee County Soil & Water Conservation District in the amount of \$83,247.21, and

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to amend the funding sources for the following projects:

Increase 1% Sales Tax Funding of \$20,772.60 to be offset by a decrease in CHIPS funding for the 2016 Road Machinery Capital Project in a like amount

Decrease 1% Sales Tax Funding of \$20,772.60 to be offset by an increase in CHIPS funding for the 2017 Large Span Culverts Capital Project in a like amount, and be it further,

**RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to amend the 2017 Budget for 2017 Large Span Culverts by increasing H5197 2797, Other Local Governments, in the amount of \$83,247.21 to be offset by an increase in H5197 2080 0000 in a like amount.

**Budget Impact:** Increase of \$83,247.21 in Aid.

**WHEREAS,** The County of Genesee desires to advance the Project by making a commitment of 100% of the non-federal share for the design and construction of the bridge; and

**WHEREAS,** The County Highway Superintendent does recommend executing the grant agreement and establishing a capital project for the replacement of the bridge, and

**WHEREAS**, The Committees on Public Service and Ways and Means did review this recommendation and do concur. Now, therefore, Be it

**RESOLVED**, That the Genesee County Legislature hereby approves the above subject Project; and be it further

**RESOLVED**, That Genesee County Legislature does hereby authorize the County Treasurer to pay in the first instance 100% of the federal and non-federal share of the cost of the Project or portions thereof; and be it further

**RESOLVED**, That the Genesee County Legislature hereby agrees that the County of Genesee shall be responsible for all costs of the Project which exceed the amount of the BRIDGE-NY Funding awarded to the County of Genesee; and be it further

**RESOVLED**, That a Capital Project be established for the Pratt Road Bridge over Tonawanda Creek in the amount of \$178,000, with \$169,100 funded from federal aid and \$8,900 funded by a local match from the 1% sales tax; and be it further

**RESOLVED,** that the Genesee County Legislature does hereby direct and authorize the Genesee County Treasurer to make the following budget amendment. Increase A1000 1110.1 1% Sales Tax in the amount of \$8,900 to be offset by an increase in appropriation A9950.9 Interfund Transfers and increase H5197 4592 Federal Aid in the amount of \$169,100. Increase H5197 5031 Interfund Transfers \$8,900 and increase H5197 2080.0000 Highway Capital Project Expense \$178,000.

**RESOLVED**, That in the event the full federal and non-federal share costs of the Project exceeds the amount appropriated above, the Genesee County Legislature shall convene as soon as possible to appropriate said excess amount immediately upon notification by the Superintendent of County Highways thereof, and be it further

**RESOLVED**, That the Genesee County Legislature hereby agrees that construction of the Project shall begin no later than eighteen (18) months after award and that the project shall be completed within three years of commencing construction; and be it further

**RESOLVED**, That the Chairperson of the Genesee County Legislature be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or State Aid on behalf of the County of Genesee with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of Project costs and permanent funding for the local share of the federal aid and state-aid eligible Project costs and all project costs within appropriations therefore that are not so eligible; and be it further

**RESOLVED**, That a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project; and be it further

**RESOLVED**, That this resolution shall take effect immediately

**Budget Impact**: A capital project will be established for the Pratt Road Bridge over Tonawanda Creek in the amount of \$178,000 with \$169,100 in federal aid and \$8,900 in local match provided from the 1% sales tax. **WHEREAS,** The County of Genesee desires to advance the Project by making a commitment of 100% of the non-federal share for the design and construction of the bridge; and
